Upon notice duly given under Arizona Revised Statutes, Section 38-431, et seq., as amended, the City Council of the City of Bullhead City held a Special Meeting on April 4, 2017, in the Council Chambers, 1255 Marina Blvd., Bullhead City, Arizona.

DISCUSSION ITEM

1. Discussion regarding a potential improvement district for the development of the Laughlin Ranch Boulevard extension from Bullhead Parkway to Highway 95.

City Manager Cotter stated a group of three developers was interested in partnering with the city through an improvement district. He said there have been preliminary discussions, and said it was time to determine if the Council was interested in moving forward. He said Laughlin Ranch Boulevard was included in the approved Section 12 master plan. He said the district would be bonded; the loan would be under the city's name, and said the developers would have to sign a note on their land and make payments. He said there were four property owners, and said one of those owners was the city. He said the arterial street was necessary to alleviate some traffic on Highway 95, cut down on emergency response time, and said the road would be a general transportation corridor improvement.

Public Works Director Agrawal stated the city had initiated several improvement districts in the past, but said the state code had since changed to require that property owners initiate the improvement districts, not the city. He said in this case, all of the property owners involved have asked the city to consider it. He said some preliminary grading work had been previously done in Section 7, but said the economy had stalled and no additional work had been done since then.

Public Works Director Agrawal said the project concept was to design half-street improvements to include one lane in both directions, a median, street lighting in the median, landscaping that would reduce future maintenance costs, water, sewer, and possibly electric. He said future expansion work would include a sidewalk and a second lane in both directions. He said a traffic signal would be needed at Highway 95 or a roundabout. He said a signal modification would be needed at the existing Bullhead Parkway signal. He said the length includes one mile in Section 7 along private property, and one-half mile in Section 12 on the city's leased land from the Bureau of Land Management (BLM).

Public Works Director Agrawal said the entire length of the road was 1.5 miles and the pavement section was 24-feet wide with 12-foot wide lanes on either side of the median. He said the street lights would cost approximately \$660,000; and said they discussed installing conduits in the beginning and adding lights at a later date. He said the total project construction and engineering cost was approximately \$3.6 million. He said the improvement district would have additional costs including construction administration, bond counsel, capitalized interest, and other legal costs. He said the project might end up being \$4.5 million in total cost, and said the city's share would be approximately \$1.3 to \$1.5 million. He said the improvement district process would take approximately three months, and said the construction window would be six to nine months.

David Lords stated this project dated back to 2005 when Laughlin Ranch Boulevard was first planned to continue to Highway 95. He said Laughlin Ranch previously had paid for a full set of plans for construction of the road and spent \$20 million on the grading work. He said the Laughlin Ranch Boulevard extension would run through Section 12 and dead end at Highway 95. He said public safety personnel have indicated the proposed roadway would cut emergency response time to Bullhead Parkway by eight minutes. He said the advantage at this time was that private citizens would pay approximately two-thirds of the cost. He said this project would open up the area to additional development similar to the DOT Foods project. He said there were only 22 acres left at the Air Park for development, and said this was a good deal for the city.

Council Member Shutts asked about the land owners. Mr. Lords stated one of the investor groups (20 acres) was from Amsterdam, another was the Lansing Companies out of San Diego (77 acres), and the third investor was the Blue Group (141 acres). He said the investors were all on board, but there was still work to be done.

City Manager Cotter stated the next step was the preliminary design costs. He said the city would be responsible for one-third of the costs, and said they would need to discuss financing methods. He said then there would be final negotiations with the group. He said the bond counsel and district engineer set the parameters of what was brought forward, and said a resolution of intent would be provided to the City Council with a public hearing. He said there would be no opposition from the land owners.

Mayor Brady asked what would happen if a land owner was uncooperative. City Manager Cotter said the property owners would have to sign a waiver of non-objection in order to move forward. He said the city would have a legal right to impose the improvement district cost upon the properties if they defaulted.

The consensus of the Council was to move forward with the improvement district process.

City Manager Cotter said last year the Council held a lengthy workshop about putting new rules in place for city access points along the river. He said one of the streets they did not identify at that time was Park Lane. He said recently Mayor Brady was approached by citizens requesting to add Park Lane to the ordinance. He said the ordinance included curfew hours restricting the hours of use for street endings with public access.

Mayor Brady stated the property owners on Park Lane would like to have the same curfew hours enforced as the other public access points to the river. He said this request was in line with what they had done in the past.

Mayor Brady asked if anyone from the public wanted to speak.

Billy Pershing asked if the proposed law applied to public beaches along the river. Vice Mayor D'Amico stated the law only applied to neighborhood street access points to the river, not the public parks.

City Manager Cotter said the Mohave County Board of Supervisors adopted a similar resolution on February 6th.

Mayor Brady said in March 2016, Arizona Supreme Court Justice Scott Bales issued an administrative order establishing a task force on fair justice for all concerning court ordered penalties, fees, and pre-trial release policies. He said the task force put together a 45-page document addressing how the courts should operate in relation to fees and fines. He said fees and fines should be reasonable and people should not be jailed unnecessarily because they were poor. He said the policy fines should be reasonable and not to put people in jail because they were not able to pay the fees. He said City Magistrate Psareas had reviewed the report and had no objections. He said he wanted the public to know the city agreed with and supported the findings of the Supreme Court.

Mayor Brady asked if anyone from the public wanted to speak.

Royanne Ortiz spoke in support of the proposed resolution.

Eva Corbett said she thought the bomb suits cost \$100,000. Police Chief Williamson said the bomb suits cost \$33,864 each.
