## **MANAGER'S REPORT**

1. 2018-2019 Budget Workshops (April 30, May 1 & 2, starting at 3:00 p.m.)

City Manager Cotter reminded the Council about the dates of the upcoming budget workshops. He said the meetings were open to the public, and said every detail included in the proposed budget could be viewed on the city's website.

## 2. Burro Issues

City Manager Cotter said everyone was aware of the burro problem in the community. He said recently there had been complaints from the Laughlin Ranch and Punta de Vista Neighborhoods. He said he met with the Bureau of Land Management (BLM) representatives in Lake Havasu City to discuss some things the city could do. He said the city would work with property owners and issue "gather requests." He said the BLM had limited resources to gather wild horses and burros. He said the city had issued several "gather requests" to the BLM; but said there was no guarantee that burros would be gathered and removed from the community. He said there did not seem to be a resolution in sight at this time. He said the city's hands were tied and they could not touch the burros. He said they needed relief from the federal government on this issue.

Mayor Brady said the BLM was in the process of testing an experimental fertility control program. He said most of the burros being tested were located on the other side of the mountain and said testing was being performed only on ten percent of the population.

## 3. Sports Tournaments and Special Events

Human Services Director Tipton discussed upcoming events in March and April. He said baseball tournaments, Kiwanis Kids' Expo, River Daze Soccer Tournament, Burro Barbeque, and the Bike Rodeo would be held in the next few weeks. He said the Farmers' Market and more baseball and soccer tournaments would be held in April. He said the Boys and Girls' Club "Kaboom" playground project would begin on April 21<sup>st</sup>.

## MAYOR AND COUNCIL MEMBERS' REPORTS ON CURRENT EVENTS

Vice Mayor Clark said Bullhead City was the first city in Arizona to recognize Vietnam Veterans' Day in March 2008. He said shortly thereafter Lake Havasu City and Kingman recognized it, and said the state had also recognized it. He said Vietnam Veterans' Day was now a national holiday.

Mayor Brady said the Home and Garden Show would be held at the Riverview Mall on March 24<sup>th</sup> and March 25<sup>th</sup> along with a car show and pet adoptions. He said DOT Foods would hold a community open house for the public on March 31<sup>st</sup>. He said a public meeting with the Arizona Department of Transportation (ADOT) regarding roundabouts would be held on April 5<sup>th</sup>.
