MANAGER'S REPORT

1. Presentation by the Boys and Girls Club of the Colorado River

Autumn Boyle-Robinson provided an annual report. She said the club served more than 1,400 children and provided over 20,000 free meals. She said the youth basketball league had 250 participants, the College for Kids programs were held in connection with Mohave Community College, a brand new playground was provided by Fiesta Bowl Charities, three summer sports camps were held, and said the club provided a Michael Phelps Foundation swimming program in partnership with Bullhead City. She said they increased the energy efficiency of the Bullhead Clubhouse with the assistance of Mohave Electric and Southface. She said summer enrollment for the three clubs saw in increase of 15 percent over last year, which was a record-breaking year. She said the new fee structure provided all parents and guardians with low monthly fees of \$60 for after school programs. She said additional scholarships were available to ensure that every child who needed the Boys and Girls Club had access. She said a Teen Center would open in October 2018 and said the Fort Mohave location would open in a temporary space. She said they had been working very hard to diversify revenues from a variety of sources included the Thrift Store. She said the revenue received allowed them to provide effective programs and ensure the safety and well-being of the children. She said expenses for the clubs were primarily focused directly on the programs. She said administration and fundraising costs were kept to a minimum. She thanked the City Council for their continued support.

2. Laughlin Ranch Blvd. Update

City Manager Cotter said the street lighting would be installed for the new Laughlin Ranch Blvd. Extension project within the next few weeks. He said a ribbon cutting date would be announced in the near future.
