Scotty McClure said EPCOR advertised that water rate discounts would be given to low income, deployed military, and veterans but said he had not received any discounts from EPCOR since he applied for them. He said they kept giving him different answers when he inquired about his bills.

He said the EPCOR employees were fortunate the city would hire them when it took over the system.

Kurt Megasier said he would like the Arizona Department of Transportation to coordinate the traffic signals along Highway 95. He said people were running red lights and causing accidents. He said the city was spending a lot of money to improve the parks, and said he did not see how the tourism industry benefited the residents. He said the city spent too much money on improving the intersection of Mohave Drive and Miracle Mile.

4. <u>PUBLIC HEARING</u>. Discussion and possible action to approve Ordinance No. 2019-13 requesting a zoning map change from C1 (Commercial: Neighborhood Sales and Service), C2 (General Commercial) and C3 (Commercial and Minor Industrial) to R-1L-PAD (Residential Single Family Limited, Planned Area Development) and approval of the Preliminary Plat for a project known as Belle Air Heights, Tract 5017, for a parcel of land that is described as Desert Shores, Tract 5007, a portion of Lot 1, Section 32, T21N, R21W. (Development Services Director Wiltse)

Council Member Clark declared a conflict of interest on Agenda Item No. 4 and left the dais.

Planning Manager Johnny Loera said the project was located east of the Bullhead Parkway and Landon Drive intersection. He said the subdivision consisted of 38.67 acres with 153 single-family home sites, and five open space parcels. He said the proposed residential lots would vary in size from 7,000 square feet to 16,156 square feet, and said all the streets would be public. He said the project would be developed in four phases with the first phase containing 15 lots. He said the Planning and Zoning Commission had recommended approval of the zoning change.

Mark Clark said his company was managing the project, and said the project would be a stick-built subdivision. He said there would be no mass grading of the project. He said the second phase would contain 22 lots, the third phase would contain 46 lots, and the fourth phase would contain 64 lots that would be built out as the market dictated. He said the average size of the home would be 1,750 to 2,000 square feet with a three car garage, and said the third car garage could be converted to an RV garage. He said the previous owners of the property had requested a mobile home or RV park. He said the neighbors were not in favor of this, and said this project would consist of only stick-built homes.

Mayor Brady opened the public hearing.

Eva Corbett said she was pleased that Council Member Clark recused himself from the item, and said the owner of the project was from another country.

Mark Clark said the owner was from Mexico City and said he was looking to develop a number of projects in the area.

Having no one else wishing to speak, Mayor Brady closed the public hearing.

Council Member D'Amico left the conference call at 5:54 p.m. and did not return to the meeting.
