## **Building, Planning and Zoning Items**

2. Discussion and possible action to approve: 1) the Final Plat for Laredo Canyon Trails at Fox Creek, Tract 5192, Unit 3; 2) the Financial Assurance through the Property Escrow Agreement; 3) the Water Allocation in the amount of 5.04 acre-feet; and 4) authorizing the Mayor to execute the agreement on behalf of the city. (Development Services Director Chooniyom)

Planning Manager Loera said the proposed project included 3.452 acres with 15 single-family lots and four parcels for drainage and landscaping. He said all necessary approvals had been granted.

Mayor Brady asked if anyone from the public wanted to speak.

Dan Alfonzo said he read the 143 pages of the final plat documents and said the plan called for 80 or 92 lots. He said the documentation stated the average lot was 7,000 square feet and another said the lots averaged 5,800 square feet. He said the lots were very small and the homes looked like storage lockers, which lowered the integrity of the surrounding neighborhood. He said there were many discrepancies in the paperwork.

Planning Manager Loera said the development included several phases and said this subdivision was the only one of three that currently could have less than 6,000 square foot lots. He said the Planning and Zoning Commission unanimously recommended approval.

City Manager Cotter said this was a 75-year agreement between Bullhead City and Arizona Game and Fish. He said as part of the second bridge project, a berm would be constructed adjacent to the Colorado River Nature Center. He said the city would maintain the berm as well as the access road for its maintenance. He said once this was finalized, all coordination necessary for the construction of the second bridge would be completed.

Mayor Brady asked if anyone from the public wanted to speak.

Billy Pershing asked about the size of the berm.

City Manager Cotter said the earth berm would be similar to a protective mound, and not a huge hill. He said it would be a few feet tall and would protect the natural environment.

Mayor Brady said the Bullhead Parkway road extension to the water's edge had been completed.

4. Discussion and possible action to authorize the city's intervention in the EPCOR Case Docket No. WS-01303A-20; WS-02156A-20 before the Arizona Corporation Commission concerning extension of its Certificate of Convenience and Necessity (CC&N) in Bullhead City. (City Manager Cotter)

# Council Member Clark declared a conflict of interest on Agenda Item No. 4 and left the dais.

City Manager Cotter said staff requests to intervene and take additional legal action in regards to EPCOR's recent filing with the Arizona Corporation Commission (ACC). He said in this filing, EPCOR seeks approval from the ACC to extend its Certificate of Convenience and Necessity (CC&N) governing water properties in Bullhead City. He said the city was very suspicious of EPCOR's motives and said the city had the right to have a seat at the table and present its legal findings before the ACC. He said the city would not be advocating the cessation of service to existing or planned customers.

City Manager Cotter said EPCOR had not been a good citizen in this community and this was another example of EPCOR gone rogue. He said it appeared that EPCOR was trying to buy all of the water systems in Arizona, but would not negotiate a purchase price for the water assets being condemned by the city despite many attempts by the city to offer a fair value. He said EPCOR had spent millions of dollars in fighting the city's attempts to simply own the water pipes, tanks and wells in the city. He said wanted to make a deal with EPCOR, but EPCOR continued to spend money and bully the City of Bullhead City.

Mayor Brady asked if anyone from the public wanted to speak.

Billy Pershing asked for clarification on the CC&N.

City Manager Cotter said the city had no discrepancy with EPCOR putting pipes in the ground for new homes but said EPCOR was rushing to clean up things with the ACC to gain value and "stick it" to Bullhead City. He said this filing would not impact the condemnation process.

Mayor Brady said EPCOR was going after several other water districts throughout the state, and included Bullhead City. He said they believed it was not necessary that the city be included in the filing.

Eva Corbett said every vote counted and urged people to vote to elect three ACC Commissioners.
