3. Discussion and possible action to adopt Resolution No. 2021R-18 approving an Intergovernmental Agreement entitled "State Plan of Operation between the State of Arizona and the Bullhead City Police Department" (Version-April 2021). (Police Chief Trebes)

Police Chief Trebes said the agreement with the State of Arizona was in connection with the Defense Logistics Agency to receive excess equipment from the Department of Defense for law enforcement purposes. He said equipment would be received at no cost to the city, and said no particular acquisition was planned at this time. He said receipt of individual pieces of equipment would take place as opportunities arose for efficiency in law enforcement missions and requirements. He said the city received a bomb robot several years ago through the program which would have been a large expense for the city.

Council Member Zehri asked about the last time the agreement was brought to the Council for consideration.

City Attorney Emery said this was similar to a cooperative purchasing agreement and said this agreement simply contained updated language that required renewal. He said the agreement did not have to be updated every year, and the prior version of the agreement had been approved a few years ago.

Mayor Brady asked if anyone from the public wanted to speak. No one from the public spoke.

4. Discussion and possible action to: 1) Adopt Resolution No. 2021R-19 authorizing submission of a Federal Transit Administration Section 5339 Bus and Bus Facilities Grant Application to fund a portion of the capital expenses for the Bullhead Area Transit System for the period starting October 1, 2021; and 2) authorize the City Manager or his duly authorized designee to execute the application, agreement, certifications, amendments, payments, and any other documents necessary to effectuate the intent of any resultant grant award. (Human Services Director Tipton)

Human Services Director Tipton said adoption of the resolution would authorize submission of a grant application necessary to fund a portion of the capital expenses for the Bullhead Area Transit System for the federal fiscal year beginning October 2021. He said the 5339 program reimbursed transit agencies for a portion of expenses using a variety of match ratios for capital costs. He said the grant would reimburse the city for at least 80 percent of eligible expenses. He said the local match was the same as the 5311 grant's local match comprised of sponsorships, advertising revenue, in-kind contributions, and general fund subsidy. He said the Arizona Department of Transportation administered the FTA 5339 program and distributed funds through a competitive grant process. He said awards were expected to be made by September 2021. He said the city would hold a public hearing at the upcoming BATS commission meeting to be held on May 3rd. He said the 5339 grant projects would include the new transit facility, engineering and design capital, and the Intelligent Transit System (ITS) replacement. He said the projects were included in the city's upcoming budget.

City Manager Cotter said a new transit facility was badly needed and said they were seeking an opportunity for a grant. He said projects had to be "shovel ready" in order to receive funding through federal programs.

Mayor Brady asked if anyone from the public wanted to speak. No one from the public spoke.
