# **Building, Planning and Zoning Items**

7. Discussion and possible action to adopt Ordinance No. 2021-10 by reference, approving amendments to Chapter 17.04, Definitions, and Chapter 17.06, General District Requirements, of the Bullhead City Municipal Code concerning swimming pools; and adopting Resolution No. 2021R-25 declaring the code amendment a public record. (Development Services Director Chooniyom)

Planning Manager Loera said the proposed amendments would address ongoing issues with swimming pools and spas. He said the amendment would specify that hot tubs and spas fall under the definition of "swimming pool." He said the current code did not define spas or hot tubs, which occasionally led to confusion on the part of residents as to whether the swimming pool regulations also applied to those other structures. He said the amendment would clarify that all related code provisions would apply to swimming pools, including barrier and setback requirements, and apply to hot tubs and spas. He said the second part addressed the location of swimming pools in single-family residential districts. He said current provisions limited swimming pools to side and rear yards only. He said this amendment would allow swimming pools to be located in front yards on lots over 10,000 square feet in size, provided the minimum front yard setback required by the density district was met for both the swimming pool and the required pool barrier. He said approval was recommended by the Planning and Zoning Commission.

He said, as of January 1, 2024, the honorarium would increase annually on the same schedule as, and equal to, any cost of living increase approved for Bullhead City employees.

Mayor Brady said members of the Council were asked to attend many meetings, work sessions, fund raising events, and attend to constituent needs. He said the honorarium would help to reimburse their personal expenses.

He asked the City Council to help him place the question on the ballot without having to obtain 1,184 signatures through an initiative process.

Mayor Brady asked if anyone from the public wanted to speak.

Dan Alfonzo said he was a firm believer in term limits. He said fresh ideas were needed in order to focus on the needs of the citizens.
