MANAGER'S REPORT

1. Introduction of the City's New Utility Department

Utilities Director Mark Clark, Deputy Utilities Director Marti Blad, City Engineer/Assistant Utilities Director Jigar Shah, Wastewater Operations Manager Jason Dukek, and Public Works Operations Manager Ryan Farnell introduced themselves to the community. They provided brief descriptions of their professional background and education.

Council Member Zehri congratulated the city for their efforts in hiring the utility employees. He asked about the plan for water conservation and improving water quality.

City Manager Cotter said the city could not guarantee water improvements anytime soon until they could take over the system and improve the conveyance of water. He said the Council would address the rates and water quality in the future.

Utilities Director Clark said the city had been spending \$200,000 in water conservation programs over the past few years, and said the city had been saving water through these efforts. He said the water was safe to drink in Bullhead City.

2. EPCOR Condemnation

City Manager Cotter said the city now had the staff to take over the water system. He said they would start the process of moving some EPCOR employees to city employment. He said according to Judge Gurtler's decision, upon the posting of an \$80 million bond, the city would take immediate possession of the water utility system.

3. Marina Blvd./Highway 95 Right Turn Lane

City Manager Cotter said the Arizona Department of Transportation would begin working on June 7th to construct a right turn lane from Highway 95 to Marina Blvd.

4. Budget Process

City Manager Cotter said a special budget meeting would be held on June 15th to approve the final budget. He said public comment would be heard at that meeting and tonight under the tentative budget agenda item.

5. Summer Boating Safety

City Manager Cotter said the city responded to 41 incidents along the river last weekend. He said it was important to keep residents and visitors safe. He said there would be a heavy police presence on the river and the beaches on the weekends.

Public Works Director Johnson said this lift truck would replace the current unit which was a 2007 Chevrolet one-ton with 116,418 miles. She said the replacement lift truck had a higher reach of 59 feet which would give access to all street lights, including the lights on Hancock Road and Highway 95. She said the current truck would be used in the parks for tree trimming and maintenance of parking lot lighting.

Public Works Director Johnson said accumulated sediment would be cleaned, allowing Fox Wash to flow more efficiently to the south and restore historic flow patterns. She said this would decrease the flood risk for the neighboring residential properties to the north. She displayed maps of the Palo Verde Meadows subdivision and said the work would remove all the properties from the flood plain.

Mayor Brady asked if anyone from the public wanted to speak.

Public Works Director Johnson said there was no cost to the city.

He said this had been a high priority for the Council and said approval of this item would begin the process with the design contract, preparation of the construction bid documents, and post-design services.

Eva Corbett asked if the culvert could be used to allow animals to cross underneath the highway.

City Manager Cotter said currently there were two culverts that allowed pedestrians to cross underneath the highway.

(Finance Director Vera)

City Manager Cotter said by adopting the tentative budget, the Council was setting the maximum limits for expenditures for fiscal year 2021-2022. He said once the tentative budget was adopted, expenditures may not be increased upon final adoption; however, they may be decreased. He said after the Council met at the budget work sessions, \$1,184,372 was added to the budget for revenue from the Federal Economic Development American Rescue Plan Act, and \$337,000 in Capital Improvements for fencing at Community Park. He said they added a second grant coordinator position (temporary) to assist the city in administrating upcoming grant applications.

Mayor Brady opened the public hearing.

Dan Alfonzo said he watched the entire budget work session. He said the city was facing a task to pay for the influx of immigrants coming through the border. He said the situation would need to be funded and coordinated with the state and federal government.

Scotty McClure said the drainage situation at Miracle Mile needed additional funding. He said the Transit Department had to fix some things, answer their phones, and needed a full-time employee. He said he thought \$140,000 was too much money to spend on a veterinarian.

Vice Mayor D'Amico said currently the city was paying \$60,000 for a veterinarian and sending animals to Kingman for shots and spay and neutering. He said those costs would go away when the city had its own veterinarian.

Barbara Pape said she previously served on the Bullhead Area Transit System Commission and said staff was very good at the time she had worked with them.

Having no one else requesting to speak, Mayor Brady closed the public hearing.
