<u>PUBLIC HEARING</u> – ZONING MAP CHANGE Z18-006 AMENDMENT #1 – Request for an amendment to zoning map change Z18-006, Ordinance No. 2019-03, Stipulation No. 7 to allow the applicant additional time (two years) to obtain permits for a project on a parcel of land that is described as the northern 52.46 acres that is generally located on the west side of Highway 95 and north of Seventh Street, described as a portion of Section 31, T21N, R21W, Bullhead City, AZ.

<u>PUBLIC HEARING</u> – ZONING MAP CHANGE Z91-025 AMENDMENT #8 – Request for a zoning map change from R1L-PAD (Residential: Single-Family Limited, Planned Area Development) to R1FB-PAD (Residential: Single-Family Factory Built, Planned Area Development) for a subdivision known as Rancho Colorado, Tract 5086 that is a portion of Section 13, T20N, R22W and Section 18, T20N, R21W.

<u>PUBLIC HEARING</u> – ABANDONMENT A21-004 – Request for abandonment of a portion of the public utility and aerial overhang easements that lie within a parcel of land located at 1869 Avalon Drive and described as Riviera Mobile Gardens Unit 3, Tract 1007, Lot 184 and a portion of Lot 185, Section 19, T20N, R22W.

<u>PUBLIC HEARING</u> – CODE AMENDMENT – COMMERCIAL AND INDUSTRIAL DISTRICTS – Request for approval of additions to Chapter 17.26, Commercial and Industrial Districts, of the Bullhead City municipal code concerning residential apartments in commercial districts.
