Harvey Pryor asked if a remote control car track could be installed at Rotary Park. He requested that code enforcement staff check into the property located at 931 Riverview Drive and other properties near the park that were in disarray.

Grace Hecht thanked the sponsors from the community that provided engraved Yeti tumblers to 20 UPS workers and 29 postal service workers that drove around with no air conditioning. She said the monthly cleanup was scheduled for August 6th.

Gary Genovese said the Chamber mixer would be held on July 22nd with a bingo fundraiser benefiting the Boys and Girls Club at Anderson Ford.

Shirlene Vogel requested that jet ski usage be limited in order to provide a safer environment on the river and beaches.

### MANAGER'S REPORT

City Manager Cotter introduced the newest staff member in City Administration, Travis Pruitt.

### 1. Homeless Shelter Update

Cathy Peterson from Catholic Charities said a cooling station was available every day at the shelter. She said the shelter was currently open 8.5 hours per day. She said they were successful in hiring the required number of employees in order to operate the shelter for overnight stays. She said they intend to open on August 1st for overnight stays. She said they needed more volunteers and thanked the Council for their support.

City Manager Cotter said the police would not tolerate anyone sleeping in the parks or under the washes when there was a place available for people to sleep. He said their hands were no longer tied and this was the path the city was taking.

## 2. Burro Update

City Manager Cotter said he and other staff members met with the Bureau of Land Management and had a conversation about burros in the Black Mountain area. He said they looked at additional mitigation measures and would continue to study them and report back to the Council. He said they would continue to warn the public about the burro activity on Bullhead Parkway.

### 3. Summer Activities and Events

City Manager Cotter said the Splash Bash event would be held in September. He said this fall, winter, and next spring were already jammed with tournaments and events in the parks.

## 4. Community Park Improvements

City Manager Cotter thanked the public works staff for all of the work they had done in the park. He discussed the numerous projects that had been recently completed.

## 5. Electric Vehicle Charging Stations

City Manager Cotter said the city was partnering with Mohave Electric Cooperative to bring charging stations to the community. He said they applied for a \$1.3 million in grant funding in order to place stations in the parks, college, airport, field house, and other locations in the area.

# 6. Staffing for New Water Company – EPCOR Employees and Transition

City Manager Cotter said the city received over 100 applicants for 16 jobs and said the full page ad was running in the paper. He said the cost of the ad publication was \$2,500 per week.

## MAYOR AND COUNCIL MEMBERS' REPORTS ON CURRENT EVENTS

Mayor Brady said MEC and TWN hooked up the first business and residential area with the fiber optic line for their internet services. He said soon the whole community would have access to affordable fiber internet service which would be a valuable asset moving forward.

3. Consideration and possible adoption of a resolution approving the sale and execution and delivery of excise taxes revenue obligations; approving the form and authorizing the execution and delivery of necessary agreements, instruments and documents; approving and authorizing the execution of an official statement to be used in connection with the sale of the obligations; delegating authority to determine certain matters and terms with respect to the foregoing and declaring an emergency. Discussion and possible action to adopt Resolution No. 2021R-44 approving the sale and execution and delivery of excise taxes revenue bonds with all necessary and appropriate transactional requirements stated therein; and further, directing the City Manager to complete, as may be additionally necessary, and in coordination with all other necessary persons and institutions, all required actions and documentation to consummate the sale approved under the resolution. (City Manager Cotter)

City Manager Cotter said this was one of the most important steps in the process of acquiring the EPCOR water system through the condemnation process. He said the court ordered the city to post an \$80 million bond in order to take immediate possession of the water system. He said the city would obtain additional funds for legal and start-up expenses. He said \$3 million would repay the general fund for legal, valuation, regulatory and other expenses. He said Utilities Director Clark was requesting \$5,250,000 to move the startup projects forward as soon as possible. He said the total bond amount, including the startup expenses, was \$90 million. He said the city was ready and able to professionally run the system. He said EPCOR fought the city every step of the way as they were unwilling to sell the water company.

Mayor Brady said EPCOR had claimed their goal was to provide safe, reliable drinking water to the citizens of the community. He said they would not cooperate with the city, only through their lawyers. He said EPCOR was not doing what they were charged to do.

Mayor Brady asked if anyone from the public wanted to speak.

Scotty McClure asked if the residents on Corwin Road in the Bermuda water system had requested the EPCOR water service. He asked if the transfer was included in the ballot language.

City Manager Cotter said the ballot language stated the city had up to \$130 million to acquire EPCOR and could acquire water companies in and around the city.

Harvey Pryor said there might be additional funds the city could spend to acquire additional water systems without asking the public.

City Manager Cotter said the city would still have the bonding capacity and the system included some customers in the North Mohave system outside of the city limits.

Council Member Wegmann said this was a long time coming and this was a proud day.

Council Member Brummett thanked the citizens and staff that worked so hard to make this happen.

Council Member Mieding urged the city to move ahead as quickly as possible.

4. Discussion and possible action to approve the "VertexOne Software, LLC and the City of Bullhead City, Arizona, VertexOne Software as a Service Agreement July 20, 2021," with monthly fees of approximately \$32,222.00 and start-up costs of \$718,439.65 as presented; authorizing waiving standard procurement practices as being in the best interest of the city; and finally, authorizing the City Manager to execute the agreement, make resulting payments, and take all actions necessary for the implementation of the agreement and the services thereunder. (City Manager Cotter)

City Manager Cotter said this agreement included the water and wastewater billing services under the city's imminent assumption of the operation of EPCOR's water system. He said VertexOne maintained EPCOR's current customer data base and coordinated with the city in great detail to ensure that billing remained seamless and as trouble free as possible amidst contentious litigation and lack of EPCOR cooperation. He said the agreement engages services from VertexOne for ten years under favorable rates that were extensively negotiated and also provided for the integration of the city's wastewater billing, and possible trash billing. He said the agreement provided for monthly services of \$32,222.00 with startup costs of \$718,439.65.

John Herron from VertexOne said they had been servicing EPCOR for over ten years, plus more than 200 customers nationwide that were about 80 percent municipalities. He said the transition would be smooth as they owned the data and files. He said the bills would look exactly like EPCOR's bills only with "Bullhead City" at the top.

Council Member D'Amico asked for information about the startup costs.

Mr. Herron said they had been working with the city for six months and had to bring the data out of the EPCOR system into the Bullhead City systems. He said the startup expense had almost already been spent in the past six months in working with the city. He said the system would assist customers in conserving water and detecting leaks.

Mayor Brady asked if anyone from the public wanted to speak.

Scotty McClure said the costs were high and asked if the city could figure out how to operate the billing systems in-house, as the numbers did not add up.

Harvey Pryor asked if the Finance Department could handle the water billing in-house.

City Manager Cotter said the software systems behind the water operations would be brought over through VertexOne, and included future wastewater and trash billings. He said the city's current system did not have the capability to do this.

City Attorney Emery said one of the greatest risks was the exposure during the transition under a hostile environment was the transfer of customer data. He said VertexOne must be used in a transfer of this magnitude.

Eva Corbett asked if the wastewater billing transfer would be an additional cost.

City Manager Cotter said there would be no additional cost.

Council Member Mieding asked if work orders were a part of the software system.

Utilities Director Clark said there special charges that were a part of the system, and said those charges would be included in the system.

Council Member Zehri asked about the term of the agreement and asked if the software was included.

City Manager Cotter said the agreement would be a long partnership of ten years, and said the city would own the data and customer information.

Police Captain Harms said the system would replace the department's current records management and dispatching system. He said the current Capers system was limited in options and support, and was not capable to adequately address all of the departmental needs. He said the Motorola system was the industry standard for public safety in the area. He said the system was used by numerous public safety operations in the county.

City Manager Cotter said Chief Trebes discussed this item during the budget discussions, and said this system was critical to protect the public.

Council Member Mieding asked about the life of the system and its technology upgrades.

Brian Dunaway from Motorola Solutions said there was no end of life to the system. He said Motorola had been the industry standard and had progressed into all aspects of public safety technology. He said their sole focus was on public safety. He said technology upgrades were included in the yearly maintenance and as needs evolved. He said the city would purchase the hardware and software and own it.

Mayor Brady asked if anyone from the public wanted to speak.

Billy Pershing asked about the cost of the system.

City Manager Cotter said the 85 month agreement with Motorola consisted of payments of a seven year period totaling \$765,600 for startup with an annual maintenance fee of \$82,818. Harvey Pryor spoke in support of the system.

He said the contract price was \$149,954 and the reimbursement rate through the ADOT 5311 Rural Transit Grant program was 80 percent.
