Grace Hecht discussed the various events that were taking place in the community. She said volunteers were needed at the homeless shelter and for Meals on Wheels.

Julie Hassett invited the public to attend the Colorado River Concert performances beginning on November 3rd.

Scotty McClure said the city's meeting hearing device was working much better. He said Circle K would not sell him a lottery ticket unless he provided his birthdate or phone number. He said people were trespassing in the wash behind the homeless shelter.

Eva Corbett invited the public to attend a fundraiser for the Mohave County Sheriffs' K-9 Unit and Saving Animals in Need Together.

Harvey Pryor requested the Council consider building an RC track in Rotary Park. He said the city should provide more park amenities for residents and not more fields for tournaments.

Billy Pershing said the Tea Party group would meet on October 30th at the public library.

Having no one else present wishing to speak, Mayor Brady closed the call to the public.

MANAGER'S REPORT

1. Annual Update from the Municipal Court

City Magistrate Pete Psareas provided an annual update of the city's court operations. He said court proceedings included criminal misdemeanors, civil violations, and protective orders. He said the number of cases had remained consistent over the last four years, even during COVID restrictions. He said fiscal year 2021 had more dispositions because people were taking advantage of COVID and not showing up. He said there were more active warrants over the last few years due to a number of circumstances. He said more people were paying their fines over the last year, possibly due to the stimulus checks. He said jail costs would increase next year because the jail had recently re-opened after being closed due to COVID. He said the Veterans' Treatment Court currently had six participants with a total of 59 past participants. He said the court held an Amnesty Day on

September 10th that resulted in quashing 59 active warrants, 68 payments received, and 14 suspensions lifted.

Council Member D'Amico asked for a report on the number of community service hours from the court.

2. Federal Recovery Funds/CARES Act

City Manager Cotter said in 2020, the city received \$4.6 million from the federal government under the AZ CARES Act. He said the funding allowed direct relief to cover expenses incurred during the pandemic. He said the city would receive a total of \$13.6 million under American Rescue Plan Act, and had received \$6.8 million to date. He said this funding was more restrictive and said most of it had been included in the approved budget for eligible projects. He said that ARPA funding would free up more dollars in the general fund. He said construction of the new second bridge would begin soon.

3. City Utilities Department/Water System Transfer

Utilities Director Clark said since the city took over the water system, they had 1,227 calls for service, or an average of 25 per day. He said the field staff had been very busy repairing line breaks and other equipment. He said they were working through the challenges.

City Manager Cotter said they had been receiving many calls from customers regarding their accounts, and said they were hiring more people in customer service to handle the calls. He said they were not charging late fees at this time. He said the Council took a tour of the facilities and saw some of the problems they were facing with the system.

4. Economic Development Update

City Manager Cotter said the Holiday Inn was about 99 percent completed. He displayed photos of the rooms. He read a list of new businesses and developments coming to the area. He said approximately 500 new single family homes would be built this year. He said the official 2020 census report for Bullhead City was 41,348.

City Manager Cotter said the proposed code amendment would allow apartments on the upper floors of commercial buildings in the C1 and C2 commercial districts by right, with no requirement for a conditional use permit, and no limitation on the percentage of the buildings that could be utilized for residential uses.

Council Member Mieding said some issues such as trash and parking would need to be addressed. He spoke in support of the amendment.

Mayor Brady asked if anyone from the public wanted to speak.

Eva Corbett asked if new structures could be built under this amendment.

Planner Loera confirmed.

Scotty McClure spoke in support of the amendment and asked if separate utility meters would be required.

Planner Loera said any issues would be addressed during the building permit process.

Billy Pershing asked about the number of stories that could be built.

Planner Loera said a height of three stories was currently the height restriction for residential structures.

(Utilities Director Clark)

Utilities Director Clark said the main influent pipe for the Section 10 plant was a 36-inch ductile iron pipe. He said each day, approximately three million gallons of sewage flowed through this pipe on its way to be treated at the plant. He said the pipe had a considerable amount of corrosion in a localized area, and said staff was concerned the pipe could rupture if it was not replaced soon.

Council Member Mieding asked about the warranty and if the city would supervise the work.

Utilities Director Clark said he would be supervising the project.

Council Member Brummett asked if service would be interrupted during the repair.

Utilities Director Clark that service would not be interrupted.

Council Member D'Amico asked about the use of iron pipe.

Utilities Director Clark said a strong material was required with withstand the pressure, and said it was a coated pipe.

Council Member Wegmann asked when the equipment would be received and installed.

Utilities Director Clark said as soon as possible.

Mayor Brady asked if anyone from the public wanted to speak. No one from the public spoke.

Utilities Director Clark said this system was the brains of the automated control of the city's wastewater collection system, wastewater treatment facilities, water production facilities, water storage facility, and water distribution system. He said the computer based system controlled the city's water reclamation plants, lift stations, wells, storage tanks, and booster pumps. He said both the wastewater and water operations communication systems were obsolete. He said they needed to standardize the wastewater and water systems to determine what componentry, community system, software, controllers and integration were the best in order to integrate the all of the above. He said staff believed the best way to answer all of their questions regarding the upgrade of the SCADA system was to bring in experts to help develop the master plan.

Council Member Zehri asked if grant funding could be used to pay for the study.

Utilities Director Clark said they would apply for as many grants as possible.

Mayor Brady asked if anyone from the public wanted to speak.

Steven Lee said he was concerned there was a risk the city could have its technology hacked and taken over by outside forces. He asked if there was a way to have backup power.

City Manager Cotter said they would not disclose any of the city's security programs.

Scotty McClure spoke in support of the item.

Eva Corbett asked if this expenditure would come under the \$5 million for system upgrades.

City Manager Cotter confirmed.

MOTION: Council Member Mieding made a motion to approve the "Supervisory Control

and Data Acquisition Master Plan Services (SCADA) Bullhead City Utilities" in the amount of \$200,000.00, contingent upon stated circumstances; and authorize the City Manager to execute the agreement and issue resultant
