Police Chief Trebes said radio communication was essential to the safety of officers, citizens, and visitors; as well as critical for interaction between personnel and other law enforcement agencies. He said the agreement included service for the radio system originally purchased in 2015 and provided all network upgrades, hardware, software, and engineering. He said project management guaranteed the network would be in a supported state at the latest versions for the duration of this agreement through July 31, 2027.

City Attorney Emery said the city had negotiated more favorable terms, and said the CPI would not be charged as an annual increase.

Police Chief Trebes said the RMS computer dispatch system was considered before, and said it was separate from the radio system.

Scotty McClure said people were trespassing through the property behind the shelter, and said the laws had to be enforced.

City Attorney Emery said the state settlement would be paid to the city, and the city would not incur any costs. He said the Arizona Attorney General had reached a settlement and requested the local governments opt into it.

Assistant to the City Manager Pruitt said the Federal American Rescue Plan Act (ARPA) funds would be granted to the River Fund upon approval by the Council.

Mike Connor, Director of the River Fund, Inc., said the organization was a critical social service agency assisting individuals who were subject to losing their housing and or becoming homeless due to the pandemic or from other reasons. He said the ARPA allowed cities to fund non-profit agencies that responded to the public health emergency with respect to COVID-19 or its negative economic impacts. He said the River Fund would qualify for this type of funding, and said there were a lot of people that could use the assistance. He said the funding would stay within the city limits. He said they had a very strong vetting process; because if they did not, they would be broke. He said they wanted to help as many people as possible.

Mayor Brady said he would like the proposed grant agreement to come before the Council for consideration and approval.

Vice Mayor D'Amico said he would like to include a provision authorizing grant funding to be spent within the Bullhead City limits.

Council Member Mieding said he would like some audit provisions included in the agreement.
