## Bid Awards, Contracts, Intergovernmental Agreement, and Purchases

9. Discussion and possible action to adopt Resolution No. 2022R-09 approving the sale and execution and delivery of excise taxes revenue bonds with all necessary and appropriate transactional requirements stated therein (presented in substantially completed form); and further, directing the City Manager to complete, as may be additionally necessary, and in coordination with all other necessary persons and institutions, all required actions and documentation to consummate the sale approved under the resolution. (City Manager Cotter)

City Manager Cotter said the bonds, in an amount not to exceed \$20,700,000, would reimburse the general fund for the general funds expended on January 28, 2022, for the final acquisition of EPCOR's Bullhead City area water system. He said this action was the result of a long and hard-fought process to improve the prospect of affordable consumer water in the city. He said pending the approach of a jury trial concerning the compensation to be paid to EPCOR, the parties engaged in a mediation which resulted in the parties reaching an agreement to conclude the acquisition of the water system for a total amount of \$100 million. He said \$80 million had already been paid in late 2021 in order to gain possession and operation of the system. He said the additional \$20 million plus statutory interest was paid in order to complete the transaction. He said this final payment resulted in the court issuing the final order of condemnation and in the city's full title and ownership of the system. He said in order to avoid the delay of acquiring bonds and thereby, delaying the full ownership of the system, the city paid the remaining amount from the general fund.

Mark Reader of Stifel, Inc. joined the meeting via Zoom conference. He said this was the final phase of the \$100 million acquisition. He said the \$80 million bond issuance previously locked into the historical low rate of 1.87 percent. He said there had been significant inflation since that time which resulted in a slight increase in interest rates. He provided market information to the Council. He said no utility rate increase would be required. He said they would sell the bonds on March 22nd.

Mayor Brady asked if anyone from the public wanted to speak.

Pamela Smith said the original bond was \$90 million. City Manager Cotter said \$80 million went toward the EPCOR payment and the remainder went toward system improvements.

Billy Pershing said the original bond approval was \$130 million. City Manager said voter approval was for the acquisition or condemnation, and said that was over.

Scotty McClure spoke in support of the acquisition.

Public Works Director Johnson said the wall would be approximately three blocks, or 24 inches tall; and would not impede the view corridor along the river. She said Lopez Construction was ready to begin construction as soon as possible.

Mayor Brady asked if anyone from the public wanted to speak.

Scotty McClure said the land south of the park would be going up for state auction soon, and wondered if the city planned to bid on it.

Mayor Brady said the extension would help to alleviate traffic from Highway 95.

Vice Mayor D'Amico said the city needed this road for its future.

Billy Pershing asked about the amount of state and private lands the city would need to purchase.

City Manager Cotter said the state would sell the land to the city through an auction process for the amount of the appraisal. He said any small piece of private land would be condemned.

Justin Francis of Haan Development joined the meeting via Zoom. He said the Arizona Department of Housing had recognized that the Bullhead City market was in desperate need of affordable housing. He said there were 147 families in the city that could use affordable housing right now. He said the Council's support was required in order to make application to the state through the very competitive process.

Vice Mayor D'Amico said the Council previously approved a similar project proposed for a Hancock Road location a few years ago, and asked about the outcome.

Mr. Francis said their bid came in fourth and their company did not make it to one of the top three applications at that time.

Discussion ensued about proposed rental amounts, rental income eligibility, and the size of rental units under the program.

Mayor Brady asked if anyone from the public wanted to speak.

Scotty McClure asked about the responsibility of the management of the rental units. He requested that the city look into a roundabout for traffic control at the intersection near the planned apartment project. He said the area did not need more housing.

16. Discussion and possible action to approve that the City Manager, or designee, apply for RAISE (Rebuilding American Infrastructure with Sustainability and Equity) grant funding and any other grant opportunities that would assist and contribute to the desired Bullhead Parkway improvements. (City Manager Cotter)

Assistant to the City Manager Edigar Kajirwa said the grant funding would come from the Infrastructure Investment and Jobs Act program, and other possible grant funding opportunities in relation to the redevelopment and beautification of Bullhead Parkway. He said with the Council's approval, the city would apply for the maximum award of \$25 million. He said the Parkway was constructed in the early 1990's and it was designed for an approximate 20-year life.

Council Member Zehri asked about the addition of bike lanes and other improvements. City Manager Cotter said they would provide the opportunity for public comment to assist in determining future parkway improvements and amenities.

Mayor Brady said the current transportation system in the city was lacking. He said they applied for right turn lanes along the highway, the second bridge project was underway, and the proposed Landon Drive and Bullhead Parkway projects would tremendously improve the roadways over the next ten years.

Mayor Brady asked if anyone from the public wanted to speak.

Billy Pershing confirmed the grant funds would come from the bill passed by Congress.

He said the only other change staff was proposing was to denominate the last Friday in November (the day after Thanksgiving) as Family Day, which was already treated as a paid holiday. He said this change would also eliminate the two half-day paid holidays now currently on Christmas Eve and New Year's Eve.

Mayor Brady asked if anyone from the public wanted to speak.

Scotty McClure spoke in opposition to the proposed schedule and automatic COLA increases.
