1. City Council Members Alfonzo, Hecht, Lizarraga, and Ring met at the Optimum (formerly Suddenlink) Center and toured the facility with City Manager Cotter and Parks and Recreation Superintendent David Heath. Immediately following the tour, the City Council returned to the Council Chambers and convened for a special meeting.

DISCUSSION ITEM

2. Discussion regarding the Optimum Center: long-term investment and the future of the facility.

City Manager Cotter said the elementary school district leased the property (former Mountain View School) to the city for \$1.00 per year, beginning in 2011. He said now was the time for major investments to be made in the property, and said the main issue was insufficient parking areas. He said they learned that some events could not handle the current parking requirements. He said the big hill adjacent to the existing parking lot could be cut down to make room for 300 to 400 cars. He said the cost of the project would be approximately \$1 million. He said the neighborhood needed the investment, and said there might be other areas within the city that would accommodate a community center.

Parks and Recreation Superintendent Heath provided information on bookings, events, and reservations at the facility. He said some of the regular activities conducted there were the community theater, free tax service, open gym for basketball and pickle ball, and rooms rented per month to non-profits, churches, and other small businesses. He said other reservations for corporate meetings, homeowner association meetings, family gatherings and parties were provided. He said they did not have a lot of weddings because no alcohol was allowed. He said the center served a vast variety of community needs.

City Manager Cotter said all of the improvements must meet ADA requirements and the cost to renovate would be approximately \$2 million. He asked if this was the right investment for the property and the area. He said they would have to hire architects and go through the process, but first they wanted to hear from the Council if they should move forward. He said if the Council was interested in moving forward, they would first contact the school district and have conversations. He said the school district would have to turn all liability and the entire property over to the city, either through a lease arrangement, or turning over the keys and management.

City Attorney Emery said further due diligence would include possible restrictions on the use of the land, which currently was an unknown. He said the power of the school district, under statute, included the privilege to sell or lease to other governmental agencies, not the private sector. He said a sale to the private sector would require a vote of their constituents. He said their current lease with the school had automatic renewals through 2040.

Mayor D'Amico said the area need the improvement, and said he would like to acquire the property before the city invested a large amount of money.

Council Member Alfonzo asked about the annual revenue received from the center.

City Manager Cotter said expenses for cleaning, maintenance, and staff time was \$128,000 in 2021 and \$126,000 in 2022. He said this year \$160,000 was budgeted. He said revenue in 2021 was \$25,800, and the 2022 revenue was \$42,600. He said Optimum provided a sponsorship fee of \$15,000 to \$20,000 per year. He said the facility was subsidized for community engagement and a not for profit center; similar to the municipal pool.

Council Member Alfonzo asked about the property on the other side of the hill. Parks and Recreation Superintendent Heath said that property was owned by the airport.

Council Member Alfonzo asked if there was a number for the cost to provide a beautiful center for the community.

City Manager Cotter said the revitalization cost for the current property was at least \$3 to \$4 million or less, and said they would hopefully use grant money to help pay for it. He said a brand new structure would cost approximately \$10 million or more.

Vice Mayor Brummett said she would support moving forward in the process. She said by the time an older building was brought up to code, it might be better to build a new building because the expense could grow.

Council Member Lizarraga said he would like to move forward in reaching out to the school district.

Council Member Hecht said she went to elementary school there and it was a wonderful facility. She said many groups used the center and it would be a wonderful investment in that area.

Council Member Ring said the project was worth investigating and the improvements would be another asset to the area.

Council Member Alfonzo asked if the structure could be used as an emergency center and cooling station.

City Manager Cotter said a backup power generator could be an investment with a long term commitment.

Mayor D'Amico asked if anyone from the public would like to speak.

Bob Horne, President of Veterans in Motion, said they were tenants in the community center. He spoke in support of moving forward. He said Veterans in Motion was looking for a piece of land to build their own facility.

The consensus of the Council was to move forward in discussions about the future of the facility with the school district.

ADJOURNMENT

Mayor D'Amico declared the special meeting adjourned at 4:24 p.m.

Vice Mayor Brummett declared a conflict of interest and left the dais.

City Manager Cotter said approval of this item would allow a fire station to be built on the parcel. He said the item was tabled at the December 20, 2022, City Council meeting to allow additional discussions between the neighborhood residents and the Fire Department.

Council Member Alfonzo said there seemed to be some inconsistencies in the paperwork, and said the original application was dated 2004. He said some of the factors the Fire Department claimed that delayed the project were irrelevant. He said a nuisance would be brought into the area with sirens at all hours, and said he thought some other locations would be better. He said in 2017, a letter was received stating the project was ready to go, and said nothing had been done for 19 years. He said it appeared there was poor planning and poor management. He said the proposed antenna would be dangerous for airplanes.

Bullhead City Fire Chief Pat Moore said the bond to fund and build the station was passed five years ago. He said the property was purchased in 2008 and the fire station was always planned to be built in the second phase of the bond, which was now. He said they attended numerous Homeowner Association meetings to discuss the planned project and met with the Laughlin Ranch Design Review Committee. He said this had been going on for ten years and the first pushback they received was last month. He said a lot of misinformation was put out about the project, and said they had not waived from their original plan. He said they notified the Federal Aviation Administration (FAA) regarding the construction and possible tower.

Assistant Bullhead City Fire Chief Scott Neal said the FAA had a portal to submit their project. He said the initial information had been submitted and a response was received from the FAA indicating the project required their approval. He said it took about four to six weeks to receive approval after the drawings were submitted.

Mayor D'Amico said the Council was voting on the zoning tonight, not the tower.

Mayor D'Amico opened the public hearing.

Jim Zaborsky said he served on the Airport Board for 21 years. He said the Fire Department presented their project to them and there were no issues. He said it was a public safety issue. He said most fire stations were located in residential areas without any problems, and he said it offered faster response times.

Dave Lords from Laughlin Ranch said the HOA and Design Review Committee approved the site and building plans with the pole. He said the homes overlooking the site were already overlooking power lines. He said the vast majority of the owners saw the station as a tremendous asset. He said the agreement was to not run sirens or lights until vehicles reached the Parkway, unless required.

Sean Regan asked how much more the project would cost in today's dollars. He said the government used the term "public safety" in order to justify spending money.

Barbara Pape asked where the funds would come from. City Manager Cotter said funds would come from property tax.

Having no one else from the public requesting to speak, Mayor D'Amico closed the public hearing.

Mayor D'Amico asked if the residents contacted the Fire Department for additional discussion. Chief Moore said they did not.
