1. Discussion on the Fiscal Year 2023-2024 Comprehensive Fee Schedule.

City Manager Cotter said the Comprehensive Fee Schedule was published on the city's website. He said each year, during the budget process, the proposed fee changes were presented to the Council for discussion and consideration. He said following the workshop, staff would post the recommended fee changes on the city's website for a minimum of 60 days and bring the recommended fee changes to the Council for consideration and adoption at the regular council meeting on May 16, 2023. He said fees adopted by the Council would become effective on July 1, 2023.

Finance Director Vera said the Development Services-Building and Zoning Departments recommended changes at an increase of one percent.

There were no questions or concerns from the Council Members.

Finance Director Vera said the Utilities Department requested the addition of a Pumping Fee (including fats, oils, and grease) at \$200.00 plus \$2.00 per gallon; Manhole Cover and Assembly Fee at Actual Cost plus 10 percent; and Fire Hydrant Relocation Fee of \$150.00.

There were no questions or concerns from the Council Members.

City Manager Cotter said staff had reviewed the current ramada rental fees and was proposing some changes. He said the proposal was to not charge for ramada rentals at Ken Fovargue Park, Rotary Park, Gary Keith Park, or Dean Hackett Park unless someone wanted to pay a premium to reserve the rental; otherwise, it would be first come, first served. He said the city was making money on the ramada rentals at Community Park. He said the recommendation was to charge \$100.00 for a Small Ramada, \$150.00 for a Medium Ramada, and \$450.00 for a Large Ramada at Community Park.

City Manager Cotter said language was included under Section A3.40.030.08 Parking and Recreation Programming that stated: "The City Manager or designee has the authority to accept donations, sponsorships, or charge fees necessary to offset costs for parking and city-run leagues, tournaments, recreation programs, or special events." He said they could simply add the language, "ramada rentals," after "parking," which would give the opportunity to be able to charge for ramada rentals at the other parks. He said staff time was involved in all of the ramada rentals.

Council Member Alfonzo asked if the costs for cleaning were included in the deposit and rental fee.

City Manager Cotter said the costs were not fully reimbursed and said a terminology change could be added to recover the total costs.

Council Member Head asked about the fees that would be charged to reserve ramadas that were not located in Community Park.

City Manager Cotter said ramada rentals for non-profit organizations were always at no charge. He said the fees would depend on the amount of staff time required and other costs associated with the individual rental.

There were no additional questions or concerns from the Council Members.

City Manager Cotter said Utilities Director Clark wanted to add a contractor fee for taking videos of the water and sewer mains.

Council Member Hecht asked about the stage use fees for non-profit organizations (\$400.00) and approved sponsors (\$260.00).

Parks and Recreation Superintendent Heath said the City Manager reviewed each request and could waive the fees. He said the \$260.00 fee was just for the transport.

Council Member Hecht asked about the abandoned shopping cart fee of \$50.00.

City Manager Cotter said they had not charged a single business for returning an abandoned shopping cart. He said the city had a full-time person cleaning up trash and a part-time person working in code enforcement collecting yard sale signs and abandoned shopping carts. He said this was a bureaucratic process and asked that the fee be stricken from the fee schedule.

There were no additional questions or concerns from the Council Members.

Building, Planning and Zoning Items

5. **PUBLIC HEARING.** Discussion and possible action to adopt Ordinance No. 2023-06 approving the request for a zoning map change from C2 (General Commercial) to R2MF (Residential Multiple-Family District) for parcels of land located at 611 to 691 Hancock Road and described as Block 1, Lots 32 through 36; and Block 5, Lots 23 through 28 of Winterhaven Estates, Tract 4069, Section 18, T20N, R22W, Bullhead City, Arizona. (Development Services Director Chooniyom)

Planning Manager Loera said the current commercial zoning had become a hardship for the property owner due to the limitations of the allowable uses, especially considering the location of the property in an area of residential development. He said the nearest adjacent developed parcels to the north, east, and west were all residential uses. He said the applicant was requesting approval of the zoning map change in order to develop the parcels with multi-family residential uses. He said

there were eleven lots covering three acres at the entrance to Winterhaven Estates. He said the applicant proposed to build 48 single-story townhomes and a block wall along Hancock Road with access to the rear. He said each unit would have a one-car garage with paved parking for two additional vehicles, for a total of three packing spaces for each unit. He said no on-street parking would be allowed as the street was only 25-feet wide. He said the residential zoning would give the Council and the city more control as to what was built there. He said if the zoning remained C-2, retail, vehicle repair garages, warehouses, or 20-foot high storage buildings would be allowed. He said Taylor Road was a privately owned strip of land and not owned by the city. He said the units would not be low income housing; they would be market rate units. He said the Planning and Zoning Commission unanimously approved the request.

Mayor D'Amico opened the public hearing.

Bart Anderson said he was concerned about vehicular access to the lots and said he thought the development would affect the traffic flow. He said it made sense to have the traffic flow onto Ramar Road.

Planning Manager Loera said the main access point would be Ramar Road, which was a signalized intersection.

Mark Carbon spoke in opposition to the zone change. He said the duplex homes did not fit into the surrounding neighborhood and said the narrow street would create traffic issues. He said property values would be decreased for the existing property owners.

Janet Deschene said her back yard was parallel to Taylor Road. She spoke in opposition to the rezoning.

Scotty McClure said the alley should be made one-way. He said two-car garages should be required in that area, and no more rentals were needed in the community.

Linda Hess said she lived in the Legacy Homes development for a number of years. She spoke in opposition to the rezoning.

Nick Parsons said currently there was no way to control the number of vehicles allowed for a single-family home.

Eva Corbett said the homes would be too close together which would create a parking problem.

Lorna Edell said she lived in Winterhaven and their back yard faced Taylor Road. She spoke in opposition to the rezoning.

Nancy Laughlin said she was concerned about the water shortage, and said more homes would have a negative effect on conservation efforts.

Raynelle Rynes said she lived in Rivers Edge and was opposed to the rezoning.

Mike Sharp said he and his partner, Kevin Barrett, were the applicants. He said, under commercial zoning, they could put in other buildings with businesses that could increase the traffic much more

than residential housing. He said residents could park one car in the garage and two cars in each driveway. He said he lived in the area, and they would own and control the rental units.

Council Member Alfonzo asked if the developers were fully funded, and when construction would begin.

Mr. Sharp said they were currently partially funded and would not have a problem getting additional funding. He said they would start the process after approval was granted by the city.

Council Member Hecht asked for the reason the developer decided to build housing, and about the anticipated amount of monthly rent.

Mr. Sharp said they were aware there was a need for more rental homes in the community, and said rent would start at approximately \$1,000.

Vice Mayor Brummett asked if additional parking spaces could be provided by not building the two single-family units at each end of the project and using those empty lots for excess parking.

Mr. Sharp said that decision would be from the Planning Department.

Council Member Lizarraga confirmed that access would not be from Hancock Road and that no parking would be allowed on Hancock. He asked if emergency vehicles would be able to fit through the narrower street.

Mr. Sharp said the width of the street was the same as the width of the streets in Laughlin Ranch, and said it was large enough to accommodate emergency vehicles.

Mayor D'Amico said commercial traffic would be much heavier than in residential neighborhoods, and traffic counts would be significantly less. He said there was a major rental housing shortage in the city.

Utilities Director Clark said the city's water entitlement was 30,000 acre-feet from the river; and said the city used almost 11,000 acre-feet of water last year. He said the general plan called for the city to build out to about 100,000 people, and said the city had plenty of water for additional growth and development.

City Manager Cotter said they believed this was a "down-zone" request, with much less impact on the neighborhood.

Council Member Head asked for clarification if Taylor Road was a street or an alley.

Planner Loera said there were some issues when the area was initially platted. He said it was a privately owned parcel and not a city right of way.

Having no one else from the public requesting to speak, Mayor D'Amico closed the public hearing.

He said the city must also be prepared to pay any expenses related to the relocation and demilitarization of the donated piece. He said the city had an obligation to maintain the Howitzer and any other piece of military equipment in the same high level condition it was today.

Mayor D'Amico said his goal was to get another piece of equipment and more memorials for the park.

Council Member Alfonzo said the pieces were on loan to the city and the city had custody of the equipment.

Council Member Hecht said hopefully the proposed legislation would pass and the city could put the lease payment savings toward the acquisition of another military piece.

Mayor D'Amico asked if anyone from the public wanted to speak.

Gary Genovese asked if the city could refuse a piece of equipment after review.

City Manager Cotter said if a piece of equipment was rejected, the city would have to start the process from the beginning.

Grace Telsner asked if the city could be liable if someone gets hurt from climbing on the equipment.

City Manager Cotter said the parks were always subject to vandalism and graffiti, and said staff quickly took care of the issues. He said additional signage would be erected at the Howitzer and police could take action if they caught people climbing on the equipment.

Nick Parsons suggested the addition of bridges connecting the two peninsulas and a boardwalk at the park site.

City Manager Cotter said the process would take time as a lot of planning was required with the U. S. Army Corps of Engineers and the Coast Guard.
