# ***HOT WATER ON DEMAND REBATE PROGRAM RESIDENTIAL ONLY***



## **ABOUT THE REBATE PROGRAM**

The purpose of this rebate program is to help our residential property owners reduce their water use by equipping their homes with an efficient hot water on demand system. These systems use a pump that is installed underneath a sink or above a water heater that recycles the hot water sitting in the pipes to reduce hot water waiting times. These systems may require an electrical outlet under the sink. If you have a faucet where the wait time to receive hot water is more than 1 to 2 minutes you may be eligible for a rebate from the City of Bullhead City.

## **ELIGIBILITY**

- A. **Authorization to Proceed:** Before purchasing/installing the hot water on demand system an application must be submitted to the City and the applicant must participate in an pre-conversion site inspection. Starting without City approval will make the conversion ineligible.
- B. **Customer Eligibility:** The property must be located within the city limits of Bullhead City. The property must be a single residential use only. The applicant must be the property owner. The property that is the subject of the application may receive only one of each rebate type (Hot water on demand, non-regenerative water softener, irrigation controller, high efficiency toilet, high efficiency washing machine, and turf) annually.
- C. **Qualifying Purchases:** Hot water on demand systems must be purchased from a business located within the city limits of Bullhead City.
- D. If an electrical outlet needs to be installed the applicant will need to apply for an electrical permit through the Building Department.

## **TERMS OF THE REBATE**

- A. **Annual Incentive Amounts:** For this budget year the City has designated funds to be used for the Rebate and Water Conservation Programs. The City's fiscal year is July 1 through June 30. Projects are subject to the availability of funds and must take place during this budget year.
- B. Rebate hot water on demand system —\$200 maximum
- C. **Important Timelines and Deadlines:** Within 60 days of approval of your application, you must complete your project and notify the City. The City will inspect completed projects for compliance.
- D. **Rebates:** **PLEASE SAVE ALL OF YOUR INVOICES/RECEIPTS.** The City must have the invoices/receipts to offer the rebate. A check will be issued to property owner approximately 30-45 days after the final inspection.
- E. **W-9 Form:** A signed W-9 form will be required with the application.
