



NON-REGENERATIVE WATER SOFTENERS REBATE PROGRAMS



RESIDENTIAL ONLY

ABOUT THE REBATE PROGRAM

The purpose of this rebate program is for property owners to switch out their current ion exchange-based water softening systems, which perform onsite regeneration of the exchange resin over to a non-regenerative water softener system. This upgraded system may be purchased or rented to be eligible for a rebate from the City of Bullhead City.

ELIGIBILITY

- A. <u>Authorization to Proceed</u>: Before purchasing/renting the non-regenerative water softener system an application must be submitted to the City and the applicant must participate in an pre-conversion site inspection. Starting without City approval will make the conversion ineligible.
- B. <u>Customer Eligibility:</u> The property must be located within the city limits of Bullhead City. The property must be a single residential use only. The applicant must be the property owner. The property that is the subject of the application may receive only one of each rebate type (Hot water on demand, non-regenerative water softener, irrigation controller, high efficiency toilet, high efficiency washing machine, and turf) annually.
- C. <u>Qualifying Purchases</u>: The non-regenerative water softener systems must be purchased or rented from a business located within the city limits of Bullhead City. If a rental agreement is entered into, the property owner will not be eligible to receive the rebate until the monthly rental fees reach the rebate amount. Proof of payments will need to be verified.

TERMS OF THE REBATE

- A. <u>Annual Incentive Amounts</u>: For this budget year the City has designated funds to be used for the Rebate and Water Conservation Programs. The City's fiscal year is July 1 through June 30. Projects are subject to the availability of funds and must take place during this budget year.
- B. Rebate non-regenerative water softener system —\$200 maximum
- C. <u>Important Timelines and Deadlines</u>: Within 60 days of approval of your application, you must complete your project and notify the City. The City will inspect completed projects for compliance.
- D. <u>Rebates: **PLEASE SAVE ALL OF YOUR INVOICES/RECEIPTS.**</u> The City must have the invoices/receipts to offer the rebate. A check will be issued to property owner approximately 30-45 days after the final inspection.
- E. <u>W-9 Form:</u> A signed W-9 form will be required with the application.
