ON MAY 26: CITY CLERK WILL THEN PROVIDE COPIES OF APPLICATIONS TO THE COUNCIL MEMBERS; SET A SPECIAL MEETING FOR THE INTERVIEWS AND SELECTION OF A COUNCIL MEMBER FOR JUNE 8 AT 9:00 A.M.; EACH APPLICANT WILL BE ALLOWED TO PRESENT FOR UP TO THREE MINUTES WITH THE OPPORTUNITY FOR EACH COUNCIL MEMBER TO ASK OUESTIONS AND RECEIVE ANSWERS FOR NO LONGER THAN TWO MINUTES EACH: PAPER BALLOTS WILL BE PROVIDED; THAT A MAJORITY VOTE WILL APPOINT; THAT ROUNDS OF BALLOTING WILL CONTINUE WITHOUT A CANDIDATE ELIMINATION UNTIL A MAJORITY VOTE IS ESTABLISHED; AND THAT IF ANY APPLICANT IS TIED BY A VOTE FOR THREE CONSECUTIVE VOTING ROUNDS, A COUNCIL MEMBER MAY MAKE A MOTION; THE APPLICANT SELECTED WILL BE SWORN IN AT THE JUNE 20, 2023, COUNCIL MEETING.
