Upon notice duly given under Arizona Revised Statutes, Section 38-431, et seq., as amended, the City Council of the City of Bullhead City held a Special Meeting on Tuesday, June 6, 2023, in the Council Chambers, 1255 Marina Blvd., Bullhead City, Arizona.

DISCUSSION ITEM(S)

1. Discussion regarding the establishment of a Metropolitan Planning Organization due to growth for transportation planning as required by the federal government. (49USC5305)

City Manager Cotter said the city had met the federal requirement to establish a Metropolitan Planning Organization (MPO), and said it came with some funding. He said the census population figure for July 2022 was 42,500 within the city limits, and said the growth of Laughlin and Fort Mohave had put them into the new category.

Assistant to the City Manager Pruitt said once an area met a population level of 50,000, there was a requirement to establish an MPO. He said the major focus of an MPO was related to all types of transportation. He said the host city was required to establish an MPO to manage road and transit planning for the area. He provided a video that described the responsibilities of the Indianapolis MPO. He said the Federal Transportation Authority had identified that the City of Bullhead City was now located in a small UZA (urbanized area). He said an Urbanized Area included clusters of population centers based on the results of each decennial census; geographic area containing populations of at least 50,000 residents; and may consist of one or more cities as well as unincorporated areas between cities and may also cross state lines. He said the area consisted of Bullhead City, parts of Laughlin (Casino Drive area), and parts of Fort Mohave.

Assistant to the City Manager Pruitt said the benefits of an MPO were professionally designed roads and transit plans; planning reflecting the region's shared vision for its future; facilitate collaboration of governments, interested parties and residents; and federal authority and state support and funding to undertake the items described above. He said the key products of an MPO were a long range transportation plan, unified planning work program, and transportation improvement program. He said public participation was important in order to develop the planning

program. He said the structure of an MPO included an Executive Board (decision making body), Technical Committee (technical expertise), planning operational staff, and other sub-committees as needed. He said staffing and operations costs were funded by the federal/state government with a 5.7 percent in-kind cost share from the host government. He said additional funding sources came from Metropolitan Planning, State Planning and Research, Surface Transportation Block Program, Carbon Reduction Program, and FTA 5305D Consolidated Planning Grant. He said the primary focus of the MPO was transportation planning for the designated urbanized area. He said urbanized areas (UZA) were population clusters of 50,000 residents, as designated by the U. S. Census bureau. He said upon designation of a UZA, the host local governing body must form an MPO. He said elected officials make the MPO policy decisions and grant final approval. He said the next steps include consulting with other government bodies within the UZA to determine participation, board and voting structure; refine and finalize the Metropolis Planning Area (MPA) map; request a resolution from the Council confirming the creation of an MPO; get letter from the Arizona Department of Transportation (ADOT) Director acknowledging the appropriate steps had been taken in developing the MPO, send a letter from the city requesting the Governor's approval; and the Governor then submits approval to the Federal Highway Authority (FHWA). He said upon the official designation of the MPO, a startup agreement contract between the MPO and ADOT would be established. He said the deadline for completion was December 2023.

City Manager Cotter said they were talking to Clark County to determine if the MPO included more or less of Laughlin. He said they needed to have the city's buses crossing the river, and said this was an opportunity to improve the transit system.

Transit Manager Peluso said the city would not lose any funding in the transition. He said they were in year one of a two-year grant cycle that would end in September 2024. He said transit could apply for the new federal funding while receiving funding under the 5311 program. He said next year's budget would be impacted, but no funding levels would change in the upcoming fiscal year. He said he was working on the transition from the 5311 to the 5307 grant program.

Council Member Alfonzo asked if the city could apply for start-up funds, and if there were ramifications if the city was late in meeting the December date. He asked if there were limitations for receiving the funding from the federal government.

City Manager Cotter said the city would receive around \$200,000 for start-up, and said the city would meet the deadline. He said the funding would have to go specifically towards the transit system.

Vice Mayor Head asked if the MPO reached into the tribal lands. City Manager Cotter said there was no obligation from the tribal entity to participate, but there were opportunities for engagement.

2. Discussion regarding the priority list of Right Turn Lanes on Highway 95.

City Manager Cotter said more than 40,000 vehicles traveled on Highway 95 in Bullhead City every day. He said peak traffic would be as many as 60,000 vehicles per day. He said the city requested ADOT funding in the amount of \$22.5 million to construct 18 right turn lanes. He said right turn lanes were needed to eliminate congestion and reduce accidents on Highway 95. He said the State of Arizona budget was recently approved with \$8 million dedicated to right turn lanes in Bullhead City. He said the money would be given directly to ADOT for engineering, design and

construction unless different parameters were established. He said they would request that ADOT fund the city directly so the city could construct the projects and help the state. He discussed the priority order of the proposed right turn lanes, as follows:

City Manager Cotter asked for the Council's comments and feedback.

Mayor D'Amico said he would prefer ADOT to do the work on areas with nearby heavy electrical equipment. He said he wanted to get the biggest "bang for the buck." He said the least priority would be the Parkway/Laughlin Bridge turn lane.

Vice Mayor Head asked about the priority of the Newberry and Mohave Drive turn lanes. City Manager Cotter said there were numerous accidents at both intersections but there were more at Mohave Drive. Vice Mayor Head said he thought that Mohave Drive should be a higher priority.

3. Presentation of the Community Survey for the New Animal Shelter. (City Council Members will give input or suggestions to the City Manager about the survey.)

Assistant to the City Manager Pruitt reviewed the proposed survey questions. He said the questions included background information, shelter services, veterinary services, self-service dog washing station, and cremation services.

Discussion ensued regarding the survey questions. The Council requested the Top 3 services category be reduced from ten service options to six, and provided their choice of options. Recommendations were made to revise the self-service dog washing station questions to change the word "nominal fee" to "\$10 to \$20" to use the dog washing station, and delete the question regarding possible harm to local groomers. Requests were made to delete the "possible harm to local veterinarians" question, and delete the "end of life" option in the priority services ranking question. The cremation services section would be deleted in entirety from the survey.

Assistant to the City Manager Pruitt said the survey would run for approximately two to three weeks, and could be longer, depending on the amount of responses received.

Council Member Ring asked if the survey could be included in the utility billings. Assistant to the City Manager Pruitt said they could include a link to the survey on the website.

City Manager Cotter said paper copies would be made available at City Hall, the senior center and other places, for those without access to a computer. He said the survey could also be published in the newspaper.

7. Discussion and possible action to approve the contract for improvements at the Section 10 Water Reclamation Plant with Kay Constructors, LLC, in the amount of \$793,827.00; and authorize the City Manager to execute the agreement and issue resultant payments. (Utilities Director Clark)

Utilities Director Clark said the project went out to bid on May 17th, and said staff held an on-site walk through of the project site where four contractors attended. He said Kay Constructors LLC was the only bidder. He said the improvements to be completed would include the installation of five pumps, guides and bases in the reuse wet well, installation of two VFDs, and exterior piping. He said this project was phase one of a two-phased project that would allow the Utility Department to pump all of the reuse water from the Section 10 plant into the Colorado River, which was approximately 3,300 acre-feet of water annually. He said the project was originally budgeted for \$675,000 in the adopted budget for fiscal year 2023. He said due to unanticipated additional costs, such as supply chain issues, funds would be moved to cover the additional \$118,827.

City Manager Cotter said there was an advantage to the city to flow water back into the river. He said there was a value to that water, and said the water would not go back into the river until the city was paid for that water.

Council Member Alfonzo asked for the reason there was only one bidder for this project.

Utilities Director Clark there was a number of reasons such as; personnel, time frame, supply chain issues, or lack of subcontractors.

Mayor D'Amico asked if anyone from the public wanted to speak.

Scotty McClure said asked if the city would receive an allotment for the water produced.

Utilities Director Clark said treated effluent would be put back into the river.

Steven Lee asked if the water was safe for drinking and would not pollute the river.

Mayor D'Amico said it was safe for drinking.

Bart Anderson asked for the reason why the reuse water was not re-distributed into the community.

Utilities Director Clark said they were looking to get credit for the water going into the river.

Nick Parsons said he hoped to prevent the State of California from taking the city's water.

Representatives of the Historical Society provided information on the new facility that would be used for storage of the collection and archives that were not on display at the museum. The educational garden was moving along, as well as additional programs for school children that would be coming in the fall.

City Manager Cotter said the funds collected through the Transient Occupancy Tax (TOT) would be re-invested in tourism activities.

City Manager Cotter said concurrent with the approval of the recently enacted vacation rental ordinance, the City Council expressed concern over noise complaints that could accompany some rentals. He said staff was directed to conduct noise meter research that could be utilized to assist in unreasonable noise enforcement. He said the Police Department researched the matter and proposed the actions included in the ordinance. He said the new provisions incorporated the use of noise meters under certain circumstances. He said the amendments in the ordinance were not specific to vacation rentals but applied to all properties and activities city-wide, and included a provision addressing local business owners desiring to play music outside at local bars.

Police Chief Trebes said the department would have more technical assistance with objective measuring tools that would help them enforce the code. He said they would purchase decibel meters that met the standard.

City Attorney Emery said the decibel meters would be another tool for law enforcement.

Mayor D'Amico asked if anyone from the public wanted to speak.

Steven Lee spoke in support of the ordinance.

Jamie Starr said 5:00 a.m. was too early and the 11:00 p.m. was a non-starter.

11. Discussion and possible action to approve the concept, design, and location for placement of the Daughters of the American Revolution "Revolutionary War Memorial" in the City's Veterans' Memorial Park. (Parks and Recreation Superintendent Heath)

Parks and Recreation Superintendent Dave Heath said the proposed location for the memorial would be on the west side of the trail, between the Navy Corpsmen Memorial and the Granite Mountain Hotshots Memorial. He said the monument would consist of a bronze plaque mounted on a large stone. He said the target date for dedication was Memorial Day 2024.

Denise Vallon from the Daughters of the American Revolution said the society's goal was to place at least one marker in every state to commemorate the Revolutionary War heroes. She said the monument would install pride in their patriotic ancestors.

Pamela Fite discussed the requirements and chapter needs in order to move this project forward. She said this would be the first marker in the state commemorating the American Revolution.

Council Member Alfonzo said he did not want the city to become a discriminating type of city as to what the wars prior to World War I had accomplished.

Council Member Hecht said as a descendent of someone in the Revolutionary War, she was proud to have this monument in the city's park.

Mayor D'Amico asked if anyone from the public wanted to speak.

Scotty McClure said he would like the location of the monument moved closer to the entrance.
