He said the equipment would be installed by Arizona Emergency Products under the Yavapai Cooperative Arrangement. He said funding to purchase the vehicles was included and approved in this year's budget. He said they would implement the warranty program before the original warranties expired.

Council Member Alfonzo asked about the amount of revenue received from auctioning the old vehicles.

City Manager Cotter said the vehicles were at end of life and sold for a few thousand dollars at public auction.

Council Member Lettman asked about the selection of particular public safety vehicles.

City Manager Cotter said the vehicles were specially made for law enforcement and limited in number.

Police Captain Harms said the 2024 vehicles were on the lot and ready to go.

Mayor D'Amico asked if anyone from the public wanted to speak.

Scotty McClure said the used vehicles sold at auction were very run down. He said the new lighting systems on public safety vehicles were too bright.

Sean Regan said bright lights were definitely needed to be seen by drivers. He asked if the new police motorcycles were on patrol.

City Magistrate Speer said the agreement supported the continued automation of the business functions of the court, which was a shared responsibility of all Mohave County courts. He said the current agreement would expire on June 30, 2024. He said the Mohave County Court automation Project had been a successful endeavor since it was first organized and implemented in 1994, as a result of a Supreme Court of Arizona administrative order. He said Mohave County provided certain equipment, technical support, and system security; and the city paid its proportionate share of fixed and ongoing court automation costs, which might include expenses for equipment, maintenance, and communications software. He said the new agreement would continue through June 30, 2029.

Council Member Lettman asked about the city's costs associated with the agreement.

City Magistrate Speer said the city would be responsible for approximately \$257,342.00 over the next five years.

Mayor D'Amico asked if anyone from the public wanted to speak. No one from the public spoke.

12. Discussion and possible action to adopt Resolution No. 2023R-48 approving the City Manager's coordination of an excise tax exempt bond issuance in an amount not to exceed \$14,200,000.00; and authorize the City Manager's execution of agreements and documents in order to successfully complete the bond issuance. (Assistant City Manager Pruitt)

City Manager Cotter said the city's expenditure limitation had been previously discussed with the City Council. He said there was a limit to the amount the city was allowed to spend. He said tonight they would explain how money could be expended for the city's projects and not exceed the expenditure limitation. He said no property tax was collected in Bullhead City, no taxes would be raised, and there was \$40 million in the city's bank account that could not be spent under the current limitation.

Mark Reader, Managing Director of Stifel Public Finance, said Bullhead City was not the only Arizona city or county in this predicament. He said a constitutional amendment was approved by Arizona voters in 1980 that controlled the expenditure of certain revenues and limited future spending increases based on population and inflation adjustments. He said the Economic Estimates Commission determined each year the expenditure limitation for each city. He said the city base limit for calculation may be modified permanently with approval of city voters. He said not every expenditure was specifically excluded under the expenditure limitation. He said a constitutional provision set forth several items that were exempt from the expenditure limitation, including: 1) amounts received from the issuance of bonds or other long-term obligations, and 2) payment of principal and interest on such bonds or other long-term obligations. He said there was an exception to the statute that would help cities, towns, and counties with this predicament until they fix it. He said the city could get short-term financing/borrowing with an exception that would allow spending of an additional \$14 million on the proceeds and the annual debt service requirements. He shared information on some recent transactions in Coconino and Maricopa Counties.

Mr. Reader provided information on 2022 election results of eighteen cities and towns that held an election for either the permanent base expenditure limit or the alternative expenditure limitation renewable every four years (home rule). He said all of those elections were successful, as the municipalities did an excellent job of educating the voters. He said 48 percent of Arizona cities and towns have adopted a permanent based adjustment and 52 percent have adopted the home rule option.

City Manager Cotter said the city would move forward in 2024 and ask the voters to approve the permanent base limit.

Mr. Reader said the final exemption amount needed was \$14,015,733, which would be funded through the issuance of tax exempt bonds to fund projects over a two-year period. He said the city had sufficient cash to make debt service payments. He said, due to the modest amount of debt and strong revenue collections, the city had significant legal borrowing capacity based on current revenue bond covenants. He said the city had strong underlying credit ratings of AA. He said they would incorporate the ability to prepay this debt quickly.

Mr. Reader said the early repayment of principal on the bonds would begin in November 2024 and be paid off by March 2025.

City Manager Cotter said the city would have to hold the debt for one year, and said interest on the bonding would be paid, but the amount borrowed would also be invested in securities and earn interest.

Mr. Reader said based on their assumptions, the estimated interest payment at 4.5 percent would be \$669,407; the estimated interest earnings at 5.21 percent would be \$471,521, and the estimated net cost to the city to borrow the \$14 million would be \$197,885. He said bids would be held on October 19th and closing would occur on or around November 2nd.

Council Member Alfonzo asked if there were pre-payment penalties and if the bonds were asset based. Mr. Reader said they were revenue bonds secured by pledged revenues of the city, and he did not think there were pre-payment penalties.

Council Member Alfonzo asked what would happen if the Council did not approve the bonding.

City Manager Cotter said the state would withhold the equal amount of funding the city spent over the cap, staff and services would need to be cut, and projects would have to stop.

Council Member Lettman asked about the exceptions to the limit.

City Manager Cotter said ARPA funding, WIFA funding, grants, loans, special assessment districts, and interest income are exempt.

Mayor D'Amico asked if anyone from the public wanted to speak.

Scotty McClure said the state law should be done away with, and asked if the funding was discussed during the budget session.

Grace Telsner said the voters had to be apprised of this issue. She asked about the outcome if the ballot issue did not pass. City Manager Cotter said the public education process had begun and would continue until next year's election.

Pamela Smith asked about the future plan for the Optimum Center. City Manager Cotter said they had been working with the school district to take ownership and renovate the entire center.

Eva Corbett said she thought the school district donated the Optimum Center to the city. City Manager Cotter said the city had a \$1 per year lease with the school district; but in order to invest millions of dollars in renovation, they city had to own the property.

Sean Regan spoke in support of the resolution.

City Manager Cotter said the city budgeted for the replacement of five police vehicles each year.

Police Captain Harms said the five vehicles were proposed to be purchased from Phil Long Dealerships, Inc. under the Cooperative Educational Services public solicitation process. He said the upfits consisted of all equipment necessary to add to a vehicle for law enforcement purposes. He said the equipment would be installed by Arizona Emergency Products under the Yavapai Cooperative Arrangement. He said funding to purchase the vehicles was included and approved in this year's budget. He said they would implement the warranty program before the original warranties expired.

Council Member Alfonzo asked about the amount of revenue received from auctioning the old vehicles.

City Manager Cotter said the vehicles were at end of life and sold for a few thousand dollars at public auction.

Council Member Lettman asked about the selection of particular public safety vehicles.

City Manager Cotter said the vehicles were specially made for law enforcement and limited in number.

Police Captain Harms said the 2024 vehicles were on the lot and ready to go.

Mayor D'Amico asked if anyone from the public wanted to speak.

Scotty McClure said the used vehicles sold at auction were very run down. He said the new lighting systems on public safety vehicles were too bright.

Sean Regan said bright lights were definitely needed to be seen by drivers. He asked if the new police motorcycles were on patrol.

Police Captain Harms said they were working on finalizing the motorcycles for street use as quickly as possible.

Gary Genovese asked if the extended warranty repairs would be performed locally.

Police Captain Harms said repairs would be local.

City Magistrate Speer said the agreement supported the continued automation of the business functions of the court, which was a shared responsibility of all Mohave County courts. He said the current agreement would expire on June 30, 2024. He said the Mohave County Court automation Project had been a successful endeavor since it was first organized and implemented in 1994, as a result of a Supreme Court of Arizona administrative order. He said Mohave County provided certain equipment, technical support, and system security; and the city paid its proportionate share of fixed and ongoing court automation costs, which might include expenses for equipment, maintenance, and communications software. He said the new agreement would continue through June 30, 2029.

Council Member Lettman asked about the city's costs associated with the agreement.

City Magistrate Speer said the city would be responsible for approximately \$257,342.00 over the next five years.

Mayor D'Amico asked if anyone from the public wanted to speak. No one from the public spoke.

Other Business

12. Discussion and possible action to adopt Resolution No. 2023R-48 approving the City Manager's coordination of an excise tax exempt bond issuance in an amount not to exceed \$14,200,000.00; and authorize the City Manager's execution of agreements and documents in order to successfully complete the bond issuance. (Assistant City Manager Pruitt)

City Manager Cotter said the city's expenditure limitation had been previously discussed with the City Council. He said there was a limit to the amount the city was allowed to spend. He said tonight they would explain how money could be expended for the city's projects and not exceed the expenditure limitation. He said no property tax was collected in Bullhead City, no taxes would be raised, and there was \$40 million in the city's bank account that could not be spent under the current limitation.

Mark Reader, Managing Director of Stifel Public Finance, said Bullhead City was not the only Arizona city or county in this predicament. He said a constitutional amendment was approved by Arizona voters in 1980 that controlled the expenditure of certain revenues and limited future spending increases based on population and inflation adjustments. He said the Economic Estimates Commission determined each year the expenditure limitation for each city. He said the city base limit for calculation may be modified permanently with approval of city voters. He said not every expenditure was specifically excluded under the expenditure limitation. He said a constitutional provision set forth several items that were exempt from the expenditure limitation, including: 1) amounts received from the issuance of bonds or other long-term obligations, and 2) payment of principal and interest on such bonds or other long-term obligations. He said there was an exception to the statute that would help cities, towns, and counties with this predicament until they fix it. He said the city could get short-term financing/borrowing with an exception that would allow spending of an additional \$14 million on the proceeds and the annual debt service requirements. He shared information on some recent transactions in Coconino and Maricopa Counties.

Mr. Reader provided information on 2022 election results of eighteen cities and towns that held an election for either the permanent base expenditure limit or the alternative expenditure limitation renewable every four years (home rule). He said all of those elections were successful, as the municipalities did an excellent job of educating the voters. He said 48 percent of Arizona cities and towns have adopted a permanent based adjustment and 52 percent have adopted the home rule option.

City Manager Cotter said the city would move forward in 2024 and ask the voters to approve the permanent base limit.

Mr. Reader said the final exemption amount needed was \$14,015,733, which would be funded through the issuance of tax exempt bonds to fund projects over a two-year period. He said the city had sufficient cash to make debt service payments. He said, due to the modest amount of debt and strong revenue collections, the city had significant legal borrowing capacity based on current revenue bond covenants. He said the city had strong underlying credit ratings of AA. He said they would incorporate the ability to prepay this debt quickly.

Mr. Reader said the early repayment of principal on the bonds would begin in November 2024 and be paid off by March 2025.

City Manager Cotter said the city would have to hold the debt for one year, and said interest on the bonding would be paid, but the amount borrowed would also be invested in securities and earn interest.

Mr. Reader said based on their assumptions, the estimated interest payment at 4.5 percent would be \$669,407; the estimated interest earnings at 5.21 percent would be \$471,521, and the estimated net cost to the city to borrow the \$14 million would be \$197,885. He said bids would be held on October 19th and closing would occur on or around November 2nd.

Council Member Alfonzo asked if there were pre-payment penalties and if the bonds were asset based. Mr. Reader said they were revenue bonds secured by pledged revenues of the city, and he did not think there were pre-payment penalties.

Council Member Alfonzo asked what would happen if the Council did not approve the bonding.

City Manager Cotter said the state would withhold the equal amount of funding the city spent over the cap, staff and services would need to be cut, and projects would have to stop.

Council Member Lettman asked about the exceptions to the limit.

City Manager Cotter said ARPA funding, WIFA funding, grants, loans, special assessment districts, and interest income are exempt.

Mayor D'Amico asked if anyone from the public wanted to speak.

Scotty McClure said the state law should be done away with, and asked if the funding was discussed during the budget session.

Grace Telsner said the voters had to be apprised of this issue. She asked about the outcome if the ballot issue did not pass. City Manager Cotter said the public education process had begun and would continue until next year's election.

Pamela Smith asked about the future plan for the Optimum Center. City Manager Cotter said they had been working with the school district to take ownership and renovate the entire center.

Eva Corbett said she thought the school district donated the Optimum Center to the city. City Manager Cotter said the city had a \$1 per year lease with the school district; but in order to invest millions of dollars in renovation, they city had to own the property.

Sean Regan spoke in support of the resolution.
