PUBLIC HEARING – ZONING MAP CHANGE Z06-004 / SUBDIVISION S05-025 AMENDMENT #5 – Request for an amendment to Z06-004/S05-025, Ordinance No. 2018-18, Stipulation No. 9 to allow the applicant additional time (2 years) to record the final plat for a project known as The Overlook that is generally located south of Laughlin Ranch Blvd. and east of the Bullhead Parkway and described as a portion of Section 8, T20N, R21W, Bullhead City, AZ.

ACTION: RECOMMEND TO COUNCIL TO APPROVE THE REQUEST FOR AN AMENDMENT TO Z06-004/S05-025, ORDINANCE NO. 2018-18, STIPULATION NO. 9 TO ALLOW THE APPLICANT ADDITIONAL TIME (2 YEARS) TO RECORD THE FINAL PLAT FOR A PROJECT KNOWN AS THE OVERLOOK THAT IS GENERALLY LOCATED SOUTH OF LAUGHLIN RANCH BLVD. AND EAST OF THE BULLHEAD PARKWAY AND DESCRIBED AS A PORTION OF SECTION 8, T20N, R21W, BULLHEAD CITY, AZ AS PRESENTED.

3. <u>PUBLIC HEARING</u> – ZONING MAP CHANGE Z04-008 – REPEAL - Request to repeal Ordinance No. 2018-23 authorizing a zoning map change from R1L-D35 (Residential: Single Family Limited with a minimum lot size of 35,000 sq. ft.) to C2 (General Commercial) for a parcel of land located at the northwest corner of Highway 68 and Landon Drive, and described as a portion of Section 21, T21N, R21W, Bullhead City, AZ.

ACTION: RECOMMEND TO COUNCIL TO APPROVE THE REQUEST TO REPEAL ORDINANCE NO. 2018-23 AUTHORIZING A ZONING MAP CHANGE FROM R1L-D35 (RESIDENTIAL: SINGLE FAMILY LIMITED WITH A MINIMUM LOT SIZE OF 35,000 SQ. FT.) TO C2 (GENERAL COMMERCIAL) FOR A PARCEL OF LAND LOCATED AT THE NORTHWEST CORNER OF HIGHWAY 68 AND LANDON DRIVE, AND DESCRIBED AS A PORTION OF SECTION 21, T21N, R21W, BULLHEAD CITY, AZ AS PRESENTED.

4. PUBLIC HEARING - CODE AMENDMENT - SWIMMING POOLS - Request for approval of an amendment to Title 17, Chapter 17.06, General District Requirements of the Bullhead City Municipal Code concerning swimming pool setbacks.
