2. <u>PUBLIC HEARING</u> – ZONING MAP CHANGE Z23-003 – Request for a zoning map change from C2 (General Commercial) to R1MH (Residential: Single-Family Manufactured Home District) for parcels of land located at 650 and 660 Daffodil Drive and described as Colorado River Gardens No.1, Lots 93 and 94, Section 19, T20N, R22W, Bullhead City, AZ.

ACTION: RECOMMEND TO COUNCIL TO APPROVE THE REQUEST FOR A ZONING MAP CHANGE FROM C2 (GENERAL COMMERCIAL) TO RIMH (RESIDENTIAL: SINGLE-FAMILY MANUFACTURED HOME DISTRICT) FOR PARCELS OF LAND LOCATED AT 650 AND 660 DAFFODIL DRIVE AND DESCRIBED AS COLORADO RIVER GARDENS NO.1, LOTS 93 AND 94, SECTION 19, T20N, R22W, BULLHEAD CITY, AZ AS PRESENTED.

3. <u>PUBLIC HEARING</u> – ZONING MAP CHANGE Z23-004 - Request for a zoning map change from R1MH-D6 (Residential: Single-Family Manufactured Home District with a density of 6,000 sq. ft. of land per unit) to R1MH-D3 (Residential: Single-Family Manufactured Home District with a density of 3,200 sq. ft. of land per unit) for a parcel of land located at 950 Sandy Beach Drive and described as Lot 367 of Colorado Riviera No. 2, Section 19, T20N, R22W, Bullhead City, AZ.

ACTION: RECOMMEND TO COUNCIL TO APPROVE THE REQUEST FOR A ZONING MAP CHANGE FROM R1MH-D6 (RESIDENTIAL: SINGLE-FAMILY MANUFACTURED HOME DISTRICT WITH A DENSITY OF 6,000 SQ. FT. OF LAND PER UNIT) TO R1MH-D3 (RESIDENTIAL: SINGLE-FAMILY MANUFACTURED HOME DISTRICT WITH A DENSITY OF 3,200 SQ. FT. OF LAND PER UNIT) FOR A PARCEL OF LAND LOCATED AT 950 SANDY BEACH DRIVE AND DESCRIBED AS LOT 367 OF COLORADO RIVIERA NO. 2, SECTION 19, T20N, R22W, BULLHEAD CITY, AZ AS PRESENTED.

4. <u>PUBLIC HEARING</u> – CODE AMENDMENT – COMMERCIAL AND INDUSTRIAL DISTRICTS- Request for approval of an amendment to Title 17, Chapter 17.26, Commercial and Industrial Districts, of the Bullhead City Municipal Code concerning the permitted uses in the C1 (Commercial: Neighborhood Sales and Service) District.

ACTION: RECOMMEND TO COUNCIL TO APPROVE THE REQUEST FOR APPROVAL OF AN AMENDMENT TO TITLE 17, CHAPTER 17.26, COMMERCIAL AND INDUSTRIAL DISTRICTS, OF THE BULLHEAD CITY MUNICIPAL CODE CONCERNING THE PERMITTED USES IN THE C1 (COMMERCIAL: NEIGHBORHOOD SALES AND SERVICE) DISTRICT AS PRESENTED.

5. *PUBLIC HEARING - CODE AMENDMENT - BACKYARD CHICKENS- Request for approval of amendments to Titles 6 and 17 of the Bullhead City Municipal Code, which would authorize the keeping of female chickens in single-family residential districts.
