PUBLIC HEARING - CONDITIONAL USE PERMIT U23-002 - Request for a conditional use permit to allow the continuous outdoor display of merchandise in a C2 (General Commercial) zoning district on a parcel of land located at 2350 Miracle Mile and described as Riverview Mall Tract 4081, Parcel C, Section 23, T20N, R22W, Bullhead City, AZ.
