2. <u>PUBLIC HEARING</u> – ZONING MAP CHANGE Z23-013 - Request for a zoning map change from C2 (General Commercial) to C3 (Commercial and Minor Industrial) for parcels of land located at 1545 and 1547 Grandview Drive and described as Colorado River Estates Re-Amended, portions of Lot 158 and 159, Section 26, T20N, R22W, Bullhead City, AZ.

ACTION: RECOMMEND TO COUNCIL TO APPROVE THE REQUEST FOR A ZONING MAP CHANGE FROM C2 (GENERAL COMMERCIAL) TO C3 (COMMERCIAL AND MINOR INDUSTRIAL) FOR PARCELS OF LAND LOCATED AT 1545 AND 1547 GRANDVIEW DRIVE AND DESCRIBED AS COLORADO RIVER ESTATES RE-AMENDED, PORTIONS OF LOT 158 AND 159, SECTION 26, T20N, R22W, BULLHEAD CITY, AZ AS PRESENTED.

3. PUBLIC HEARING – REDEVELOPMENT PLAN – Request for approval of the City Center Redevelopment Plan, creating a redevelopment area in portions of Sections 19, 20 and 29, T20N, R22W in accordance with Arizona Revised Statutes §§ 36-1479 & 36-1471. The redevelopment area extends along Riverview Drive from San Carlos Drive on the east side to Riviera Boulevard on the west side, along the south side of Marina Boulevard from Highland Road to Lakeside Drive, and along Lakeside Drive from Marina Boulevard on the north side to Riverview Drive on the south.

ACTION: RECOMMEND TO COUNCIL TO APPROVE THE REQUEST FOR APPROVAL OF THE CITY CENTER REDEVELOPMENT PLAN, CREATING A REDEVELOPMENT AREA IN PORTIONS OF SECTIONS 19, 20 AND 29, T20N, R22W IN ACCORDANCE WITH ARIZONA REVISED STATUTES §§ 36-1479 & 36-1471. THE REDEVELOPMENT AREA EXTENDS ALONG RIVERVIEW DRIVE FROM SAN CARLOS DRIVE ON THE EAST SIDE TO RIVIERA BOULEVARD ON THE WEST SIDE, ALONG THE SOUTH SIDE OF MARINA BOULEVARD FROM HIGHLAND ROAD TO LAKESIDE DRIVE, AND ALONG LAKESIDE DRIVE FROM MARINA BOULEVARD ON THE NORTH SIDE TO RIVERVIEW DRIVE ON THE SOUTH AS PRESENTED.
