* If you have been cited for A.R.S. 28-645A3A - Red Light Violation or A.R.S. 28-647 - Disobey Flashing Signal, and plea or are found responsible of the charge, Arizona Motor Vehicle Division may require you to attend a Traffic Survival School pursuant to the requirements of the Arizona Revised Statutes.

**If you have been cited for A.R.S. 28-4135A/B/C and plea or are found responsible of the charge Arizona Motor Vehicle Division is required to administratively suspend the driver's license and registration associated with the charge. The court may reduce or waive the penalty. Please contact the court for more information, (928) 763-0130 bullheadcitymunicipalcourt@courts.az.gov.

If you are under the age of 18 and plea or are found responsible of a moving violation Arizona Motor Vehicle Division may require you to attend a Traffic Survival School pursuant to the requirements of the Arizona Revised Statutes. If you are eligible for Defensive Driving School and complete the class no later than 7 days prior to your court date you may not be required to attend Traffic Survival School by the Motor Vehicle Division.
