1. Budget amendments for program expenditures for the end of FY 2024.

Finance Director Drexler said during the year-end process, staff will go through all expenditures, outstanding purchase orders, and any last minutes purchases for each line item in the budget. He said staff will then research to see if any budget amendments will be needed for each department and the total budget. He said he wanted everyone to understand that staff is not raising the budget, they are simply moving funds from one account into another account.

Finance Director Drexler said last year, the Police Department planned on receiving a new boat through the grant process. He said the boat was backordered and it was not received until this fiscal year. He said staff needed to adjust the budget to cover the expenditure.

Finance Director Drexler said the city came into some property during the EPCOR takeover and said a budget amendment was needed to pay the outstanding property taxes on the properties.

Finance Director Drexler said the Parks Department did not have a lot of savings to cover overages. He said when staff went through the process of taking over EPCOR, they examined all the city accounts and realized EPCOR was undercharging some of the accounts. He said now that the correct charges are being made to the proper accounts, the cost has become more than anticipated. He said another change to the Parks Department budget is the additional cost of refuse due to more homeless cleanups.

Finance Director Drexler said another budget amendment is for the Victim Services Department. He said the grant year is October 1-September 30. He said during last years budget process, they did not know the amount of the grant, so staff budgeted the same amount as the previous year. He said the city was awarded more money than was budgeted for, so they are moving the funds from Legal Services to Victim Services to maximize the grant usage.

Finance Director Drexler said another budget amendment is for city vehicles. He said they decided to purchase the vehicles this year instead of next year because of significant savings in this years budget.

Finance Director Drexler said this year, staff plans on adding an additional \$6-7 million to the general fund.

Steven Lee spoke about clot shots and a doctor that can turn off the instructions of the clot shot that effectively create blood clots and turn off your immune system and alter your DNA.

Barbara Pape said the Colorado River Republican Women's Club will have their July luncheon at Chaparral County Club.

Robert Ensley said he is representing the Noon Kiwanis Club. He said they have hosted the Cornfest event for the past seven years, and said they are concerned because another event offering some of the same types of activities will take place on the same weekend as Cornfest. He said their event is to raise funds and to give the money back to the community. He said he did not know where the competing event's funds will be going, but it will not be going to the community. He said they were frustrated because they spoke with city staff about it and said they felt dismissed. He said Bullhead City is a small community, and said two big events should not be scheduled for the same day.

She said they also pull one pet from the shelter every Monday and speak about it on the KNACK radio station. She said an event will take place on July 4th at the Laughlin Ranch Golf Course. She said Swanty's Chrysler is sponsoring the 50/50 raffle for the event. She said on July 12th the Mimosa Mosaic for Mutts event will take place at Vista Del Sol.

Jim Fuller read a Scripture from the Bible and expressed his support for Ashley Gerich.

Jon Deese said he wanted to introduce himself because he is running for Precinct 3 Constable.

Nick Parsons said tomorrow at 3:00 he will be speaking about the basics of solar power at the Mohave County Library.

Pamela Smith said the Bingo and Burgers event will take place on June 24th at Chaparral Country Club.

Gary Quick said more people are adding solar power to their homes. He said solar companies are now supplying energy to the grid. He said homeowners are responsible for the maintenance and upkeep of their panels, and said they are also responsible for any damage the solar panels may cause to their homes.

Gary Genovese spoke in favor of the Mohave Valley Peak Power Plant that is currently being proposed in Mohave Valley. He said this item will be heard at the July 1st Board of Supervisors meeting. He said the power plant is needed to help alleviate brown outs and black outs during the summer.

Scotty McClure said he was upset because Tom Brady left before he had a chance to speak about his previous comments. He said people needed to study the sample ballot and Proposition 416.

1. Respond to city comment at the last city council meeting regarding treatment of a dog

Police Chief Trebes said at the last city council meeting, a member of the public said an animal control officer mistreated a puppy. He said he watched the bodycam video of the incident, and said all accusations are false. He said the animal control officer was never rude to the person that was turning in the puppy, nor did they mistreat the puppy in any way. He said he spoke with the person that made the accusation and said they viewed the bodycam video. He said the person making the accusations agreed that the officer acted in a professional manner and never mistreated the puppy. He said the person that made the accusation told him they will attend the next council meeting and publicly apologize and set the record straight. He said the person did not show up to tonight's meeting. Mayor D'Amico said he also watched the bodycam video and said he was happy with the interaction he saw.

2. Bridge Grand Opening June 7

City Manager Cotter said the new bridge is officially open, and said the grand opening ceremony was fantastic. He showed a short video of the grand opening event.

3. New Soccer Stadium for City and Mohave Community College

City Manager Cotter said the new soccer stadium opened last week. He showed a short video highlighting the groundbreaking ceremony. He said the Mohave Community College men's and women's soccer will be played at the field as well as championship games for the city and promotional soccer tournaments. He said a \$250,000 grant was received from the Arizona Office of Tourism for some of the improvements. He thanked Medhi Azarmi and Butch Redmond for volunteering with the project. He said the city does own the stadium and the fields, and said the college will use the facility for their home games and practices.

4. Bullhead City Recreation Summer Camp

Public Information Officer Covert said this is the second year in a row the recreation department has offered a summer camp series. He said the program will run from May 28-June 28 and said over 30 camps have been offered. He said science camp will be offered for the next two days at a reduced rate and basketball camp will be offered for half price. He said he spoke with several of the parents and said they are extremely pleased with the camps and the security measures staff have taken with the children and the parents.

5. City Incorporation Celebration – 40 years

City Manager Cotter said a community party will take place on August 25th at Community Park to celebrate the City's 40th incorporation anniversary. He said more information about the event will be presented at a later date.

6. Cooling Stations

City Manager Cotter said the following cooling stations are open: The Legacy Foundation Christine Stamper Center for Health and Hope is located on Oatman Road; the Salvation Army is located at 1461 Palma Road; and the Bullhead Senior Campus is located on Trane Road. He said the city government monitors the heat throughout the summer, and said cooling centers and shelters have been set up in the past as needed. He said additional cooling centers will be established when there are three days of sustained heat of 120 degrees or more. He said in the event of a power outage, the city will work with Mohave Electric to find out how long the power may be out for. He said if the power is expected to be out for a long period of time, the city is prepared to set up a cooling station and a shelter if needed.

7. TWN Presentation

Jeremy Brunk said he was representing TWN Communications. He said they are scheduled to begin installing their fiberoptic networks in Bullhead City on June 24th. He said work will begin on Hancock Road north to the river and on the northwestern side of Highway 95. He gave a brief PowerPoint presentation showing the areas where work will begin, some of the equipment that will be used, and the finished product.

Planning Manager Loera said this project is made up of five parcels covering approximately 5 acres in the Sunridge Estates subdivision. He said the current zoning is multi-family which will allow up to 80 units. He said the owner is requesting the zoning change because he believes that the site is better suited for a single-family development. He said the applicant plans to develop 36 single-family townhome lots. He said if this item is approved, staff will bring the final plat drawings before the Council for their approval at a later date.

Mayor D'Amico opened the public hearing. Having no one wishing to speak, Mayor D'Amico closed the public hearing.

9. <u>PUBLIC HEARING:</u> Discussion and possible action to adopt RESOLUTION NO. 2024R-30, approving an amendment to the Land Use Plan of the Bullhead City General Plan to change the land use designation from Park/Open Space to High Density Residential for a 1.19 acre parcel of land located at 490 Riverview Drive and described as a portion of Government Lot 1, Section 25, T20N, R23W, Bullhead City, AZ. (Development Services Director Chooniyom)

City Manager Cotter said Items 9 and 10 are for the same parcel and project, but two separate items and motions are needed.

Planning Manager Loera said this parcel is an odd piece of land that runs along Rotary Park. He said the only way to access this property is through an easement that runs along the north side of Rotary Park. He said the parcel used to be government owned, and said at some point is was sold to private parties and has changed hands several times. He said the General Plan designation was never changed, and said it is still designated as Park/Open Space. He said to change the zoning, the General Plan needs to be changed to High Density Residential.

Mayor D'Amico asked if the applicant was present.

Alejandro Bingochea said he is the property owner and the applicant. He said they purchased the property almost a year ago, and said they would like to change the zoning from commercial to multifamily residential.

Mayor D'Amico opened the public hearing. Having no one wishing to speak, Mayor D'Amico closed the public hearing.

10. <u>PUBLIC HEARING</u>: Discussion and possible action to adopt ORDINANCE NO. 2024-20, approving the request for a zoning map change from C2 (General Commercial) to R2MF-D2 (Residential: Multiple-Family with a density of 2,000 square feet of land per unit) for a 1.19 acre parcel of land located at 490 Riverview Drive and described as a portion of Government Lot 1, Section 25, T20N, R23W, Bullhead City, AZ. (Development Services Director Chooniyom)

Planning Manager Loera said this item goes along with Item 9. He said city records show that at some point the parcel was rezoned to General Commercial, and said the applicant is requesting to change it to Residential Multiple-Family. He said the applicant plans to build up to 25 townhomes across 4 buildings. He said the buildings will be up to 30 feet high, and said they are planning to build carports instead of garages. He said the only access to the property is through a Bureau of Land Management

easement that runs along the north end of Rotary Park and would have to be tied into Riverview Drive to provide access to the site. He said the fire department will approve the plan with the stipulation that it meets the fire code regulations for fire truck turnarounds.

Council Member Alfonzo asked Planning Manager Loera if he has received any objections from residents in the area. Planning Manager Loera said staff sends letters to all property owners within a 300-foot radius of the proposed project and said staff has not received any feedback. Council Member Alfonzo asked Planning Manager Loera if he thought the project would cause traffic congestion in the area. Planning Manager Loera said the only access to the project will be through the easement.

Mayor D'Amico said there would be a lot of units on one acre and said he was concerned about what would happen if there was a fire. He said he felt better knowing that fire sprinklers will be installed. Mayor D'Amico said he was concerned about the right of way access because they would have to enter into a lease with the Bureau of Land Management for continued use of the right of way. He said the road into the property is rough and said he would like the road to be paved. Planning Manager Loera said the road will have to be paved.

Mr. Bingochea said the area will be paved and cleaned up. He said they were asked if they could save one of the trees and said they will do everything possible to either move the tree to a different location or donate it. He said they currently have paperwork pending with the Bureau of Land Management to lease the right of way for 50 years. He said they tried to purchase the easement, but they meet only 2 of the 3 requirements, and said the federal government is not interested in selling the land at this time.

Mayor D'Amico said he would be in favor of this item if it was stipulated that the right of way be paved. Mr. Bingochea said the plans that were submitted showed the right of way is paved up to the cul-de-sac.

Council Member Hecht asked Mr. Bingochea why he chose to build the project at the proposed location and how the project will benefit the community. Mr. Bingochea said multi-family housing is needed in the area. He said he and his wife have been in the real estate business for over 20 years and said they have done everything from selling homes to flipping homes. Council Member Hecht said housing was needed in the community, and said she was glad Mr. Bingochea was investing in the community.

Council Member Lizarraga asked Mr. Bingochea how many parking spaces each unit will have. Mr. Bingochea said each unit will have two parking spaces.

Mayor D'Amico opened the public hearing. Having no one wishing to speak, Mayor D'Amico closed the public hearing.

City Manager Cotter said this item is for rental space for Dr. Michael Cavallaro of the Pest Abatement District.

Council Member Alfonzo said he visited the office space and asked Dr. Cavallaro if there will be any flammable chemicals or any chemicals that omit a strong odor stored at the location. Dr. Cavallaro said no such chemicals will be stored at the location.

Mayor D'Amico asked if anyone wanted to speak on this item. No one from the public spoke.

(Utilities Director Clark)

Utilities Director Clark said the city currently has approximately 22,000 Neptune meters in the system and said Core and Main was the sole supplier of Neptune Meters. He said Core and Main has purchased Dana Kepner and decided Core and Main will no longer carry Neptune meters. He said staff purchased a large quantity of meters to have in stock to get through the transition. He said they saved approximately \$50,000 by purchasing the meters when they did, and said the cost of the meters will probably increase by \$71.00 per meter. He said they usually keep approximately 200 meters in stock, and said they have enough so they will not have to order any more for a few months.

Mayor D'Amico asked who pays for the meters when there is a new development. Utilities Director Clark said the city pays for the meters.

Council Member Alfonzo asked if the city will be able to purchase similar meters when the current stock is depleted. Utilities Director Clark said they found out that Ferguson will be carrying Neptune meters so they will still have a supplier.

Mayor D'Amico asked if anyone wanted to speak on this item. No one from the public spoke.

City Manager Cotter said the proposed intergovernmental agreement allows the city to have its incarcerated individuals housed at the Mohave County Jail. He said the daily fee for a prisoner to be incarcerated is \$110.61 and a booking fee of \$91.89.

Council Member Alfonzo asked if the prisoner pays any part of the fees. City Manager Cotter said some pay part of the fees, and said it is very rare that the city recovers the entire cost.

Council Member Hecht said the cost to the city is very high, especially for repeat offenders. She complemented Hildy Angius on her efforts to get a facility built near the jail that will offer the help they need from existing services in the community.

Mayor D'Amico asked if anyone wanted to speak on this item. No one from the public spoke.

MOTION: Vice Mayor Head made a motion to adopt Resolution No. 2024R-31, approving

the City's entry of an Intergovernmental Agreement with Mohave County for prisoner detention services and costs, and approving expenditures in the approximate amount of \$307,000.00. Council Member Hecht seconded the

Other Business

14. Discussion and possible action to approve the "Legacy Connection Assistance Grant" in the amount of \$35,000; authorizing the City Manager to execute the Agreement and issue payment; and further, authorizing the transfer of \$35,000 from contingency to fund the grant agreement. (Human Services Director Tipton)

Human Services Director Tipton said if approved, this item will help provide clothing, jackets, school uniforms, and school supplies to children in need in Bullhead City. He said the Legacy Connection was able to serve 4,896 children residing in the Bullhead City School District for Fiscal Year 2023-2024. He said programs such as Backpack Buddies and Coats for Kids are a growing segment of need, and said this allocation will help support the rising need and cost increase for area families and the most vulnerable youth.

Teri Tomlinson, Vice President of Legacy Foundation Program Development, thanked the city for helping to support their youth programs. She said the Backpack Buddies Connection Express kicked off in January 2024, and said they are estimated to serve 800 Bullhead City youths this upcoming academic year. She said from July 2023 through June 2024 they served 893 youth which is an increase of 72 percent compared to last year. She said the participation rate average is 92-96 percent compared to 36-40 percent in prior years. She said 1,400 pairs of pants were purchased with city grant funds, and said 1,786 were distributed to Bullhead City students. She said the cost per student has increased from \$80 to \$110 and said they are estimating they will spend approximately \$88,000 during the next academic year. She said the total number of Bullhead City youth served from July 2023 through June 2024 is 4,896.

Mayor D'Amico asked if anyone wanted to speak on this item. No one from the public spoke.

MOTION: Council Member Ring made a motion to approve the "Legacy Connection

Assistance Grant" in the amount of \$35,000; authorizing the City Manager to execute the Agreement and issue payment; and further, authorizing the transfer of \$35,000 from contingency to fund the grant agreement. Lizarraga seconded
